Dear Speaker Won Pat:

Transmitted herewith is Bill No. 356 (LS), "AN ACT TO *ADD* A NEW ARTICLE 1A AND A NEW § 4119.1 TO CHAPTER 4 OF TITLE 4 OF THE GUAM CODE ANNOTATED RELATIVE TO CREATING A MILITARY FAMILY LEAVE ACT OF GUAM," that I signed into law on January 30, 2009 as Public Law 29-149.

The bill provides leave without pay to government of Guam family members and authorized representatives of a qualified member of the military deployed during a period of military conflict. Because the bill does not establish parameters with some of its provisions, the bill could have unintentional consequences.

For example, the bill does not define an authorized representative of a qualified service member. Fotentially anyone could be designated as an authorized representative by a qualified service member and therefore eligible for military family leave. Further, the bill does not appear to limit the designation by the qualified service member and could exponentially increase the number of qualified employees per qualified service member. It is unclear whether this is the intent of the Act.

In addition, the law provides leave to qualified employees if the qualified service member is deployed during a period of military conflict. This could apply to qualified service members deployed to Guam from Guam. Again, it is unclear whether this is the intent of the Act.

It is unclear whether the military family leave is meant to apply to anyone designated as an authorized representative of a qualified service member and whether it is meant to apply to service members deployed to Guam from Guam. It seems the law could impact productivity in the workplace.

Therefore, I respectfully recommend we revisit and amend the law to ensure the intent to allow leave for military family members of qualified service members deployed from Guam to designated combat zones is clearly established in the Act.

## AN ACT TO *ADD* A NEW ARTICLE 1A AND A NEW § 4119.1 TO CHAPTER 4 OF TITLE 4 OF THE GUAM CODE ANNOTATED, RELATIVE TO CREATING A MILITARY FAMILY LEAVE ACT OF GUAM.

1	BE IT ENACTED BY THE PEOPLE OF GUAM:
2	Section 1. A new Article 1A is hereby added to Title 4 of the Guam Code

**§4A101. Title.** Article1A of Title 4, Guam Code Annotated, is hereby created to make its title the *Military Family Leave Act of Guam (MFLAG)* and throughout the Chapter the acronym *MFLAG* will be referred to as this Act.

§4A102. Purpose. In order to serve the families of those troops currently 7 serving in military conflicts in Iraq, Afghanistan, and throughout the world, 8 serving in the Global War on Terrorism, and to assure that these families are 9 able to spend time together during the qualified service member's leave to and 10 from deployment, to include pre-deployment, post-deployment, during 11 deployment, any return for Rest and Relaxation (R&R) leave during 12 deployment or reintegration from deployment, and to handle their personal 13 affairs by their spouse or designated next of kin or attorney-in-fact, it is 14 necessary that this Act take effect immediately. 15

**§4A103. Definitions.** The following definitions *shall* be used in interpreting this Article.

(a) *Qualified Employee* means a person who satisfies all of the
following:

20 (1) Is the spouse, authorized representative, designated
21 next of kin, *or* attorney-in-fact of a qualified member.

(2) Performs service for hire for an employer for an
average of twenty (20) or more hours per week, but does not
include an independent contractor.

25 (3) Provides the qualified employer with notice, within
26 two (2) business days of receiving official notice that the qualified

member will be on leave from deployment, of his or her intention 1 to take the leave provided for in §4A104 of this Article as 2 3 requested. (4)Submits written documentation to the qualified 4 employer certifying that the qualified member will be on leave 5 from deployment during the time the leave provided for in 6 subdivision (e) is requested. 7 Qualified Employer means any government of Guam 8 (b)instrumentality, Military related unit on Guam, municipal village 9 instrumentality, public authority, or any other governmental entity on 10 Guam subdivision, that employs fifteen (15) or more employees. 11 *Period of military-conflict* means either of the following: (c)12 A period of war declared by the United States (1)13 Congress; 14 A period of deployment for which a member of a 15 (2)reserve component is ordered to active duty pursuant to either of 16 the following: (i) Sections 12301 and 12302 of Title 10 of the 17 United States Code, or (ii) Title 32 of the United States Code. 18 (d)*Qualified Service Member* means a person who is any of the 19 following: 20 (1)A service member of the Armed Forces of the United 21 States who has been deployed during a period of military conflict 22 to an area designated as a combat theater or combat zone by the 23 President of the United States; or 24 A service member of the National Guard who has (2)25 been deployed during a period of military conflict; or 26

A service member of the Reserves who has been (3)1 2 deployed during a period of military conflict. Qualified leave period means the period during which the (e) 3 qualified service member is on leave from deployment during a period of 4 military conflict, to include pre-deployment, post deployment, return for 5 rest and relaxation (R&R), reintegration, or after deployment. 6 **§4A104.** Leave Required. Notwithstanding any other provision of law, 7 a qualified employer may allow a qualified employee to take *up to* fifteen (15) 8 days of unpaid leave during a qualified leave period. 9 §4A105. Provisions. 10 A qualified employer shall not retaliate against a qualified (a) 11 employee for requesting or taking the leave provided for in this Section. 12 (b) The leave provided for in this Section shall not affect or 13 prevent a qualified employer from allowing a qualified employee to take 14 a leave that the qualified employee is otherwise entitled to take. 15 This Section shall not affect a qualified employee's rights (c)16 with respect to any other employee benefit provided for in other laws." 17 A new §4119.1 is hereby added to Chapter 4 of Title 4, Guam Section 2. 18 Code Annotated, to read: 19 "§4119.1. Military Family Leave Act. The provisions of the Military 20 Family Leave Act of Guam (MFLAG) contained in Article 1A of Title 4, Guam 21 Code Annotated, shall apply to all qualified employees of the government of 22 Guam as defined in this Chapter." 23
