"RELATIVE TO APPROVING THE FORTY-THREE (43) NEW FEES"

WHEREAS, the Board of Trustees Planning & Finance Committee met on February 27, 2009, reviewed and recommended that the Board of Trustees approve the Forty-Three (43) new fee items; now, therefore, be it

WHEREAS, the GMHA Board of Trustees has reviewed the list of new fees and found the same to be in order; and

WHEREAS, the Hospital has realized One Hundred Thousand Twenty-Two Dollars and Cents Thirty-Nine (\$100,022.39) in revenues since the inception of the new fees in FY2009; now therefore be it,

RESOLVED, that the Board of Trustees accepts and approves the recommendation of the Planning & Finance Committee and adopts the Forty-Three (43) new fee items; and be it further

RESOLVED, that the GMHA Board of Trustees directs the Hospital Administrator/CEO to continue to proceed with the adjudication process of these Forty-Three (43) new fee items; and be it further

RESOLVED, that the Chairperson certifies and the Secretary attests to the adoption of this resolution.

MINUTES

In accordance with the Administrative Adjudication Law, a public hearing was held on Monday, December 29, 2008, at 2:00 p.m. in the GMHA Boardroom, to solicit public opinion on the Hospital's 43 New Rates Fees and Charges.

Present were: (Refer to Exhibit 10 - GMHA Public Hearing Attendance Sheet).

Note: Copies of the Public Hearing Agenda (Refer to Exhibit 9 – GMHA Public Hearing Agenda) and the Listing of Hospital Fees (Refer to Exhibit 3 - GMHA Summary of Fee Items/Services) were made available to all attendees.

I. <u>Introduction</u>

Ms. Jane Flores introduced herself as the Presiding Public Hearing Officer for this public hearing and began conducting the public hearing at 2:27 p.m., Monday, December 29, 2008. Our public hearing recorder was Ms. Candy Chan.

She indicated that the hearing was publicly announced to start at 2:00 p.m. but we had allowed some time for additional attendees from the public to attend this hearing.

II. **Opening Remarks**

On behalf of the GMHA Board of Trustees, the Hospital Administrator, and the GMHA employees, Ms. Flores welcomed the public for being present at the public hearing.

III. <u>Purpose of the Public Hearing</u>

Ms. Flores stated that the purpose of this public hearing was based on the following enactment cited under Public Law 26-66 passed in December 2001, which removed the rate-setting jurisdiction from PUC and gave it to the GMHA Board of Trustees:

10 GCA §80105 Hospital Rates

"(b) The Authority may establish interim fees for new, un-tariffed services, medication and supplies, without prior legislative approval and without compliance with the Administrative

Adjudication Law; provided, that : (1) the interim fees are consistent with the Authority's Net Revenue Enhancement Engagement Pricing Model, as prepared by Deloitte & Touche, dated February 7, 1992, or such other protocol as may be approved by the Board of Trustees; and (2) a petition for permanent approval of the interim fees is filed by the Authority with I Liheslaturan Guahan within three (3) months of the Authority's establishment of the interim fee."

Ms. Flores added that the Hospital had a total of twenty (20) public hearings during fiscal years 2002 through 2009. A total of 3,175 new fees/services and 2,181 updated professional fees had been introduced and adjudicated.

Ms. Flores stated that in compliance with the Administrative Adjudication Law and further Guam Code Annotated directives, the Hospital did publish in the Pacific Daily News and the Marianas Variety the announcement of this public hearing (Refer to Exhibit 5 - GMHA Newspaper Notices of Public Hearing) and distributed the Notice of Public Hearing to all Hospital departments and units and also posted in public areas within the Hospital.

In addition, the Hospital also sent the Notice of Public Hearing via facsimiles to various news media organizations, the Offices of the Governor and Lieutenant Governor, the Congressional Representative, and to our elected Senators of the 29th Guam Legislature (Refer to Exhibit 6 - GMHA Fax Notifications of Public Hearing). In addition, letters were sent to the third party payers (Selectcare, NetCare, Takecare and Staywell, etc.) inviting them to this public hearing along with the listing of new fee items for presentation (Refer to Exhibit 7 - Letters inviting Third Party Payers to Public Hearing).

The Hospital also posted the Notice of Public Hearing in its official website as mandated by public law (Refer to Exhibit 8 – Press Release Notice of Public Hearing displayed in GMHA website).

IV. Presentation of Summary of New Fee Items

Mr. Frumen Patacsil introduced himself being in charge of the Hospital's Charge Master Library. He indicated that the Hospital has introduced a total of Forty-Three (43) new fee items/services submitted by various departments of the Hospital for the past three months. The summary of these fee items/services were as follows:

V. <u>Testimonies from the Public</u>

It was noted for the record that attendees from the public, employees of the Hospital or representative from the media did not present any testimony. Ms. Flores indicated that the public could submit any written testimony to the Hospital Administrator within five (5) days after this public hearing. These written testimonies would be incorporated into the submission package to the 29th Guam Legislature, subsequent to the review and approval by the GMHA Board of Trustees.

VI. Questions and Answers on the Hospital Rates Fees and Charges

It was noted that there were no questions presented by the attendees concerning the 43 new fee items presented today at the hearing. It was also noted for the record that attendees present here at the hearing could submit or address any questions or concerns to the Hospital Administrator.

VII. Closing Remarks

In closing, Ms. Flores thanked everyone for making the time in their busy schedule to attend this public hearing. The schedule of the next public hearing on hospital fees would be duly publicized in order for everyone to have the opportunity to attend the hearing.

VIII. <u>Adjournment</u>

Ms. Flores called the hearing to adjourn at 2:31 p.m., December 29, 2008, Monday.

*<u>Note</u>: All respective parties were informed of the date, time and place of this public hearing prior to the hearing.

For record purpose, no written testimony was received following the five-day extension.

British PM announces Iraq troop withdrawal plan

BAGHDAD (Reuters) — Prime Minister Gordon Brown announced the end of Britain's involvement in the Iraq war on Wednesday, saying almost all its troops would be out by the end of July next year.

Brown's fourth trip to Iraq as prime minister coincided with the drafting by the Iraqi government of a law that obliges British forces to withdraw in mid-2009, more than six years after the U.S.-led invasion.

His trip was not announced in advance, for security reasons, and followed a visit on Sunday by U.S. President George W. Bush, who had to dodge shoes thrown by an Iraqi journalist angry at the sectarian slaughter unleashed by the invasion.

Shortly after Brown met Prime Minister Nuri al-Maliki, twin bomb blasts in Baghdad killed 18 people and wounded 53, in a reminder of the violence that has only recently begun to wane.

"The role played by the UK combat forces is drawing to a close. These forces will have completed their tasks in the first half of 2009 and will then leave Iraq." Brown and Maliki said in a joint statement.

"But the partnership between the two countries will continue to take on new dimensions."

Britain. Iraq's former colonial power, was the United States' main partner in the war. Its forces have shrunk to just 4,100 soldiers now based near the southern city of Basra, where Brown headed after a brief visit to Baghdad.

Britain says its work in the south of Iraq is done and that Basra is now safely in the hands of Iraqi security forces.

"They've done some of the most difficult work ... building a democracy for the future and defending it against terrorism." Brown said of the 100,000 British soldiers he estimated had served in Iraq since 2003.

"I said we would stay until we'd finished the job we set out to do. The tasks that we set out to do have been done and that's why we can take a decision to bring most of our forces home," he said later, just before leaving Iraq.

People questioned in Basra, which controls most of Iraq's oil exports, seemed unlikely to miss Britain's presence.

"I do not think the British forces brought any benefit to Basra, not before and not now," said Muntazer Jabar, 55, a retired military officer who runs a supermarket.


"There's no need for them to delay their withdrawal. It'd be better for them and for us if they withdraw now."

The withdrawal could help Britain focus on Afghanistan, where the Taliban and other groups are stepping up attacks.

Britain has said it will transfer helicopters from Iraq to Afghanistan, giving its 8,300 troops there greater mobility, but there are no plans to increase troop numbers.

British defense sources say it has become almost impossible to sustain military operations in two theatres.

The law setting out terms for the British withdrawal also covers the remaining Australian, Estonian, Romanian, Salvadoran and NATO troops, and needs the approval of the Iraqi parliament.







5 GCA § 10306 (2004)

§ 10306. Information Required on Official Home Pages.

The following information is required to be posted on each Official Home Page for each Branch of the government of Guam:

Notice of Meetings and Public Hearings. Notice of all public meetings, public hearings and other public events for which notice is required under the provisions of Public Law, or applicable rules and regulations, shall be posted on the applicable Official Home Page by the minimum period of notice required for such meetings. Such notices posted shall include information generally required to be included in the publication of such notices.

The e-mail addresses of all official offices, departments, agencies and instrumentalities of the Branch of government.

Any web sites or home pages of all official offices, departments, agency and instrumentality of the Branch of government.
