Re: Transfer of funds to the Citibank Construction Subaccount

Dear Mr. Lacson:

The above referenced account was recently established pursuant to Amendment Number One to the Disbursement Procedures for the Citibank Trust Account, as approved by the District Court of Guam in an Order dated August 11, 2009. The amendment to the Disbursement Procedures also requires that we transfer to the Citibank Construction Subaccount "the \$20,000,000 which was received from the Government of Guam's loan from the Bank of Guam in January 2009, less capital expenditures made from these funds through the date of the transfer of funds." The amended procedures further provide that "Funds deposited to this sub-account shall be used exclusively for Consent Decree projects in accordance with the requirements of Government of Guam Limited Obligation (Section 30) Bonds, Series 2009A."

The attached schedule calculates the amount to be transferred to the Citibank Construction Subaccount by subtracting from the initial \$20,000,000 loan from the Bank of Guam all of the capital expenditures made from these funds through today. The amount to be transferred is \$15,523,734.87.

Therefore, pursuant to the amended Disbursement Procedures for the Citibank Trust Account and the Order of the District Court in this matter dated August 11, 2009, please transfer immediately \$15,523,734.87 from account number 0-000131-474 (GBB, The Receiver for the Government of Guam DPW) to account number 0-000131-490 (Citibank Construction Account).
