EXECUTIVE ORDER NO. 2009 - 17

RELATIVE TO AUTHORIZING OVERTIME FOR EXEMPT AND NON-EXEMPT EMPLOYEES OF THE DEPARTMENT OF ADMINISTRATION, GENERAL SERVICES AGENCY, THE BUREAU OF BUDGET AND MANAGEMENT RESEARCH, AND DEPARTMENT OF EDUCATION TO ENSURE THE FISCAL CONCERNS OF THE U.S. DEPARTMENT OF EDUCATION ARE ADDRESSED

WHEREAS, it is the intent of the parties to serve as an interim solution to the management information system while the Government of Guam awaits funds from the American Recovery and Revitalization Act or "ARRA" funds to put in place a more permanent solution; and

WHEREAS, all parties acknowledge that this is not a "takeover" of the functions of the Department of Education (DOE) but rather intensive training program that would ensure the fiscal concerns of the U.S. Department of Education are addressed; and

NOW THEREFORE, I FELIX P. CAMACHO, I Maga' Lahen Guahan, Governor of Guam, by virtue of authority vested to me by the Organic Act of Guam, as amended, do order:

- 1. Overtime. This Executive Order shall authorize overtime compensation effective August 12, 2009 until such time deemed unnecessary by the Directors of the Department of Administration, Bureau of Budget and Management Research, and Department of Education;
- 2. Employees. The Director of the Department of Administration, the Director of the Bureau of Budget and Management Research, and the Superintendent of the Department of Education shall authorize overtime compensation to designated employees of the Department of Administration, Bureau of Budget and Management Research and Department of Education employees who are responding to this Executive Order including the following exempt employees:



EXECUTIVE ORDER NO. 2009-19

RELATIVE TO AMENDING EXECUTIVE ORDER NO. 2009-17 AUTHORIZING OVERTIME FOR EXEMPT AND NON-EXEMPT EMPLOYEES OF THE DEPARTMENT OF ADMINISTRATION, GENERAL SERVICES AGENCY, THE BUREAU OF BUDGET AND MANAGEMENT RESEARCH, AND DEPARTMENT OF EDUCATION TO ENSURE THE FISCAL CONCERNS OF THE U.S. DEPARTMENT OF EDUCATION ARE ADDRESSED

WHEREAS, Executive Order No. 2009-17 authorized overtime for exempt and nonexempt employees of Department of Administration, General Services Agency, Bureau of Budget and Management Research and Department of Education as the government collaborates to address USDOE's fiscal concerns regarding their federal funds;

WHEREAS, an amendment is necessary to properly include the specific positions at BBMR to ensure the employees are compensated for overtime work.

NOW THEREFORE, I FELIX P. CAMACHO, I Maga' Lahen Guahan, Governor of Guam, by virtue of authority vested to me by the Organic Act of Guam, as amended, do order:
