



**AN ACT TO *ADD* A NEW SUBSECTION (h) TO
§40128 OF CHAPTER 40 OF TITLE 5, GUAM
CODE ANNOTATED, RELATIVE TO ACTIONS
TAKEN BY THE MUNICIPAL PLANNING
COUNCILS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new Subsection (h) is hereby *added* to §40128 of Chapter 40 of
3 Title 5 of the Guam Code Annotated to read as follows:

4 “(h) The Municipal Planning Council *shall* act as the body politic with
5 the power to make its own rules, establish committees, hold hearings, and to
6 prepare, pass, and adopt resolutions. *If* a resolution from a Municipal Planning

1 Council requests action from *I Liheslaturan Guåhan*, the resolution *shall* be
2 received by the Rules Committee, or its equivalent, of *I Liheslaturan Guåhan*.”
