AN ACT TO RENUMBER §§20119 AND 20120, AND TO ADD NEW §§20119 AND 20120 TO CHAPTER 20 OF TITLE 19, GUAM CODE ANNOTATED, RELATIVE TO PROHIBITING DISCRIMINATION FOR GOVERNMENT OF GUAM PROGRAMS SOLELY ON THE BASIS OF CONVICTION OF A STATUS OFFENSE.

#### BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. §§20119 and 20120 of Article 1, Chapter 20 of Title 19, Guam
- 3 Code Annotated, are hereby renumbered as §§20121 and 20122.

1 New §§20119 and 20120 are added to Article 1, Chapter 20 of Section 2. 2 Title 19, Guam Code Annotated, to read as follows: **"§20119.** 3 Records of Status Offenders. The juvenile records of individuals who have been convicted of only a status offense(s) shall be 4 sealed and not available to any party without a valid court order. 5 6 **§20120.** Records Discrimination Against Status Offenders 7 **Prohibited.** No government agency or program may, solely on the basis of 8 conviction of a status offense, discriminate against any person who would otherwise be eligible. No private entity that receives government of Guam 9 10 funding, either local or federal funds, for any of its programs may, solely on the basis of conviction of a status offense, discriminate against any person 11 who would otherwise be eligible." 12
