“RELATIVE TO APPROVING THE ONE HUNDRED THIRTEEN (113) NEW FEES AND THE EIGHT THOUSAND ONE HUNDRED SIXTY-SEVEN (8,167) UPDATED PROFESSIONAL FEES”

WHEREAS, Public Law 26-66, places the rate making authority of the Guam Memorial Hospital Authority under the GMHA Board of Trustees; and

WHEREAS, the GMHA Board of Trustees has reviewed the Public Law 26-66; and

WHEREAS, a Public Hearing was held on June 7, 2010 and oral comments and written testimony have been solicited for the One Hundred Thirteen (113) new fees comprised of the following Hospital departments: Central Room Supply, Radiology, Pharmacy, Operating Room, and Special Services; and

WHEREAS, the Public Hearing was also held to update the Eight Thousand One Hundred Sixty-Seven (8,167) Professional Fees; and

WHEREAS, the Board of Trustees Finance & Audit Committee met on June 14, 2010 and July 13, 2010, reviewed and recommended that the Board of Trustees approve the One Hundred Thirteen (113) new fee items and the 8,167 updated professional fees; and

WHEREAS, the Board of Trustees has reviewed the lists of new fees and the updated professional fees and found the same to be in order; and


WHEREAS, the Hospital has realized Five Hundred and Six Thousand Seven Hundred Thirteen Dollars and Cents 74/100 (\$506,713.74) in revenues since the inception of the 113 new fees in FY2010; now therefore be it,

RESOLVED, that the Board of Trustees accepts and approves the recommendation of the Finance & Audit Committee and adopts the 113 new fee items and the 8,167 updated professional fees, and be it further

MINUTES

In accordance with the Administrative Adjudication Law, a public hearing was held on Monday, June 7, 2010, at 9:30 a.m. in the GMHA Daniel L. Webb Conference Room, to solicit public opinion on the Hospital's 113 new fees and the 8,167 updated Professional Fees.

Present were: (Refer to Exhibit 11 – Attendance Sheet).

Note: Copies of the Public Hearing Agenda (Refer to Exhibit 10) and the Listing of New Fees (Refer to Exhibit 3) were made available to all attendees.

I. Introduction

Ms. Frances Danieli introduced herself as the Presiding Public Hearing Officer for this public hearing. Our public hearing recorder was Ms. Candy Chan. Ms. Danieli indicated that this public hearing was originally advertised to start at 9:30 a.m. but, we allowed a grace period of fifteen (15) minutes for additional attendees from the public to find parking to attend this hearing. She began conducting the public hearing at 9:45 a.m.

II. Opening Remarks

On behalf of the GMHA Board of Trustees, the Hospital Administrator/CEO, the Chief Financial Officer, and the GMHA employees, Ms. Danieli welcomed the public for attending the public hearing. She then commenced presenting the purpose of the public hearing today.

III. Purpose of the Public Hearing

The enactment of Public Law 26-66 in December 2001 removed the rate-setting jurisdiction from the PUC and gave it to the GMHA Board of Trustee:

10 GCA §80105 Hospital Rates

“(b) The Authority may establish interim fees for new, un-tariffed services, medication and supplies, without prior legislative approval and without compliance with the Administrative Adjudication Law; provided, that: (1) the interim fees are consistent with the Authority's Net Revenue Enhancement Engagement Pricing Model, as prepared by Deloitte & Touche, dated February 7, 1992, or such other protocol as may be approved by the Board of Trustees; and (2) a petition for permanent approval of the

interim fees is filed by the Authority with I Liheslaturan Guahan within three (3) months of the Authority's establishment of the interim fee.

Ms. Danieli indicated that the Hospital had a total of twenty-seven (27) public hearings during fiscal years 2002 through 2010. A total of 3,446 new fee/services and 2,181 rate increased items had been introduced and adjudicated.

Ms. Danieli stated that in compliance with the Administrative Adjudication Law and further Guam Code Annotated directives, the Hospital did publish in the Marianas Variety and Pacific Daily News the announcement of this public hearing (Refer to Exhibit 5 – Notice of Public Hearing) and distributed the Notice of Public Hearing to all Hospital departments and units and also posted in public areas within the Hospital.

In addition, the Hospital also sent the Notice of this Public Hearing via facsimiles to various news media organizations, the Offices of the Governor, the Congressional Representative, and to our elected Senators of the 30th Guam Legislature (Refer to Exhibit 6 – GMHA Fax Confirmations of Notifications). Letters were also sent to the Third Party Payers inviting them to this public hearing with the listing of new fee items (Refer to Exhibit 7 – Letters inviting Third Party Payers to Public Hearing).

The Hospital also posted the Notice of Public Hearing on its official website as mandated by public law (Refer to Exhibit 9 – Press Release displayed on GMHA website).

IV. Presentation of Summary of New Fee Items

Mr. Luis Miclat introduced himself being in charge of the Charge Master Library. He stated that we were presenting today a total of one hundred thirteen (113) new fee items submitted by various departments of the Hospital for the past three months. The summary of these new fee items/services were as follows:

Mr. Miclat added that the Hospital also updated a total of 8,167 Professional Fees in our Charge Library. This update was in effect on April 13, 2010.

He stated that due to the volume of the updated Professional Fees listing, we were unable to prepare copies for all attendees. A sign-up sheet was prepared for request of the listing, which would be provided via electronic format after the hearing (Refer to Exhibit 12).

V. Testimonies from the Public

Ms. Danieli noted that no individual at this hearing had signed up for testimony. She informed that the public could submit a written testimony within five (5) days after this public hearing. These testimonies would be incorporated into the submission package to the 30th Guam Legislature, subsequent to the approval by the GMHA Board of Trustees.

VI. Questions and Answers on the Proposed New Rates, Fees and Charges and Existing Fee Schedule

Ms. Danieli stated that we would like to solicit any questions from the public that they might have concerning the 113 new fee items and the 8,167 updated professional fees presented at this public hearing. It was noted that there were no questions from the attendees.

VII. Closing Remarks

In closing, Ms. Danieli thanked everyone for making the time in their busy schedules to attend this public hearing. The next public hearing on hospital new fees would be scheduled in the fourth quarter of this fiscal year.

VIII. Adjournment

Ms. Danieli called the hearing to adjourn at 9:51 a.m.

*Note: All respective parties were informed of the date, time and place of this public hearing prior to the hearing.

Representatives from the office of Senator Aguon and Calvo’s Selectcare had signed up to request for the listing of professional fees. They also requested that we provide them the notes we prepared for this hearing. It was noted that we already provided the listing and the notes via electronic mail after the public hearing.



Iran and Russia clash in worst row in years

TEHRAN (Reuters) — Iran and Russia clashed on Wednesday over Kremlin support for draft U.N. sanctions against the Islamic Republic, in one of the worst rows between the two powers since the Cold War.

The public clash indicates growing concern in Tehran after the United States said Russia and China, the closest thing Iran has to big-power allies, had agreed to a draft sanctions resolution to punish Iran over its nuclear program.

In unusually strong criticism of Russia, President Mahmoud Ahmadinejad admonished the Kremlin for bowing to what he said was U.S. pressure to agree to sanctions and bluntly warned President Dmitry Medvedev to be more cautious.

"If I were the Russian president, when making decisions about subjects related to a great nation (Iran) ... I would act more cautiously, I would think more."

Ahmadinejad said in a televised outdoor speech.

He said that Russian support for the United States was unacceptable and that Moscow should rethink its decision or face being viewed as an enemy by Tehran.

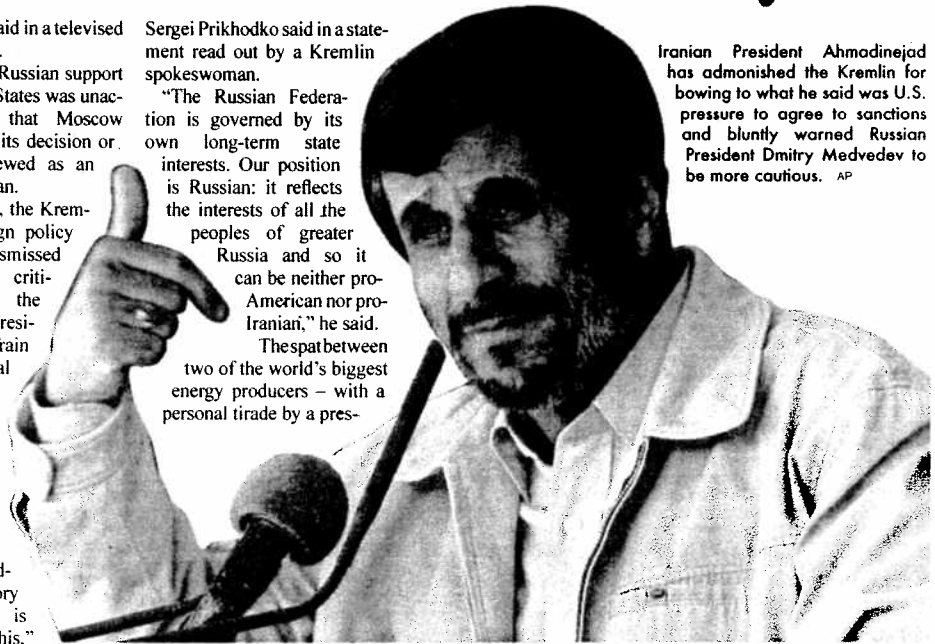
Within hours, the Kremlin's top foreign policy adviser dismissed Ahmadinejad's criticism, telling the Iranian president to refrain from "political demagoguery."

"No one has ever managed to preserve one's authority with political demagoguery. I am convinced, the thousand-year history of Iran itself is evidence of this,"

Sergei Prikhodko said in a statement read out by a Kremlin spokeswoman.

"The Russian Federation is governed by its own long-term state interests. Our position is Russian: it reflects the interests of all the peoples of greater Russia and so it can be neither pro-American nor pro-Iranian," he said.

The spat between two of the world's biggest energy producers — with a personal tirade by a pres-

ident against a Kremlin leader — is the worst in many years, analysts said.

Though trade ties have grown over the past two decades, Russia is still regarded with deep distrust in Iran after several wars between Persia and the Tsarist Empire, followed by rocky relations with the atheist Soviet Union.

Russia has been dismayed by Tehran's failure to disclose full details about its nuclear program and diplomats say privately that Kremlin leaders have been burned several times while attempting to get Iranian leaders to resolve the dispute.

Prikhodko issued a clear rebuke to Tehran over its failure to allay fears about its nuclear program.

"Any unpredictability, any political extremism, lack of transparency or inconsistency in taking decisions that affect and concern the entire world community is unacceptable for us," he said.

"It would be good if those who are now speaking in the name of the wise people of Iran ... would remember this."

Since the 1991 fall of the Soviet Union, trade has grown, reaching \$3 billion last year. Russia has struck deals to build Iran's first nuclear power station and sell billions of dollars of weapons.

But the row with Moscow could hurt plans to start the Russian-built nuclear reactor at the Bushehr power plant in August and Iran is unlikely to see a Russian delivery of the S-300 surface-to-air missiles it ordered from Moscow.

"Moscow has repeatedly saved Iran from very tough sanctions, so Ahmadinejad's defiance is quite frankly out of place," Pyotr Goncharov, a Moscow-based specialist on the Gulf, told Reuters.

"It is simply the latest attempt by the Iranian president to lay the blame for his own problems at someone else's door."

Ogilvy tied for lead at Memorial

Geoff Ogilvy dropped into a three-way tie atop the Memorial leaderboard, giving up the outright lead by carelessly missing a par putt inside 3 feet.

The consolation for Ogilvy was a 7-under 65 and a share of the lead Thursday with Rickie Fowler and Justin Rose. They were two shots ahead of a group that included Phil Mickelson, who can go to No. 1 in the world with a victory.

Defending champion Tiger Woods finished 18 holes, even if he looked ordinary. He overcame two early bogeys with consecutive birdies around the turn and shot an even-par 72. For Woods, a four-time winner at the Memorial, it was the first time since 2004 that he failed to break par in the opening round.

Ogilvy took the outright lead at 8 under and had a 15-foot birdie putt on the par-3 eighth when he missed. Without marking the ball, he stepped over it and watched the tap-in spin out of the cup.

Wales Open

England's Chris Wood shot a 6-under 65 in the Wales Open to match the record on Celtic Manor's Twenty Ten Course — the site of the Ryder Cup matches in October — and take a one-stroke lead over Wales' Bradley Dredge.

Wood matched the course record set last year by Simon Dyson.

Italy's Edoardo Molinari, England's Richard McEvoy and France's Raphael Jacquelin opened with 67s, and New Zealand's Danny Lee topped a group at 68.

Judge rules against Gannett paper

MADISON, Wis. — The Wisconsin school athletic association has the right to limit who carries games live on the Internet, a judge ruled Thursday.

U.S. District Judge William Conley ruled that the Wisconsin Interscholastic Athletic Association's exclusive agreement with the video production company When We Were Young Productions doesn't stifle media freedom.

In a 51-page decision, Conley noted that media outlets can stream games not produced by When We Were Young Productions for a fee. As for games the company does stream, media outlets can still publish stories, offer opinions and offer limited live coverage, the judge said.

"Ultimately, this is a case about commerce, not the right to a free

press," Conley wrote.

The ruling came in a lawsuit between the Wisconsin Interscholastic Athletic Association and The Appleton Post-Crescent newspaper, its parent company, Gannett Co., and the Wisconsin Newspaper Association. The sports association sued after The Post-Crescent streamed live coverage of four high school football playoff games in 2008.

The newspaper claimed the deal between the sports association and the video production company violated the constitutional right to freedom of the press and the equal protection clause.

A spokesman for the sports organization, Todd Clark, said he had not yet seen the ruling Thursday evening but that the association was pleased with the victory.

"We've run our tournaments in a reasonable fashion. We're actually

very happy it was in our favor," Clark said.

Bob Dreps, the attorney who represented Gannett Co. and the newspaper association, said in a written statement that the defendants were disappointed Conley authorized the "continued commercialization of high school sports." The defendants were considering their options, including a possible appeal, Dreps said.

According to Conley's decision, the sports association began searching for new revenue sources in 2004. When We Were Young Productions approached the organization in 2005 and offered to distribute video of games through all forms of electronic and broadcast media, including the Internet.

No one else expressed any interest in transmitting games online. The sports association entered into a decade-long deal with When We

Were Young, giving the company the exclusive right to produce, sell and distribute all tournament series and championship events, except the football and hockey state finals and the state boys and girls basketball tournaments, which are covered under other contracts.

Not public forums

In his ruling, Conley said the games aren't public forums and the contract doesn't threaten to silence opposing viewpoints.

"Defendants are free to publish accounts of the tournaments in newspapers and television, to interview the players and coaches and even to display up to two minutes of live video coverage of any game. In fact, the Internet streaming policy does not prohibit defendants from expressing a single thought, opinion or analysis about a game," Conley wrote.

Legendary coach Wooden hospitalized

LOS ANGELES — Former UCLA basketball coach and Hall of Famer John Wooden has been hospitalized in Los Angeles, according to Bill Walton.

The former UCLA star said Thursday night that the 99-year-old Wooden was at UCLA Medical Center, where Walton last visited with him two days ago.

Walton spoke at the NBA finals, where he declined to comment on Wooden's condition.

"He's the greatest," Walton said. "We love him."

Los Angeles television station KCAL and the Los Angeles Times first reported that Wooden was in "grave" condition.

The Times cited an anonymous

school source who said Wooden's health has been an issue in recent weeks and that he was briefly hospitalized about a month ago.

UCLA spokesman Marc Dellins told The Associated Press he spoke to a Wooden family member Thursday evening and that the family asked that no other information about Wooden be released.

UCLA Medical Center spokeswoman Roxanne Moster said she couldn't confirm whether Wooden

was there or not because it would be a "violation of medical privacy laws."

Family members couldn't be reached for comment Thursday by the AP.

Coaching legacy

Wooden led the Bruins to 10 NCAA championships — at one time winning seven in a row — during a 27-year run that ended with his team cutting down the nets one last time in 1975. The Bruins won 88 consecutive games from 1971-74 and 38 consecu-

tive NCAA tournament games from 1964-74, both records.

NBA commissioner David Stern was asked about Wooden's contributions to the sport of basketball before Game 1 of the NBA finals between the Los Angeles Lakers and Boston Celtics on Thursday night.

"We decided that we would not declare his obituary now, other than to say that he's the winningest coach in our history, four 30-0 seasons, and the ultimate aficionado of our game," Stern said. "We hope he's in peace right now, and we'll wait on events."

§ 10306. Information Required on Official Home Pages.
