a. \$27.3M GovGuam apppropriation revenue is based on ACCRUAL BASIS, allocating allotment request based on 10 months of fiscal year budget (Not no of PPE). Cash received as of July 31, 2010, is \$ 23.2M. Therefore, GovGuam is \$4M in arrears for FY10 allotm b. \$ 422K increase in net assets using ACCRUAL BASIS, but \$3.6M decrease using CASH BASIS of GovGuam appropriations.
