Attached to this memorandum is a report identifying various discrepancies discovered during an inspection of the Benavente Middle School that took place on September 13, 2010. I strongly recommend that GDOE address the discrepancies identified and rectify them immediately in order to come into compliance with the various provisions of the Fourteen (14) Points of P.L. 28-45, the School Sanitation Code, and/or other laws or regulations of the various regulatory agencies.

Please be advised that not all classrooms or school facilities were inspected. Therefore, GDOE is highly encouraged to asses all other classrooms and school facilities in order to identify any other discrepancies and perform corrective action as necessary. In addition, during the course of the inspection it was discovered that every student restroom visited did not have any paper towels or other means. In addition, it was also discovered that the school did not have a supply of paper towels on hand. After looking into some of the trash containers in the various restrooms, there was no evidence of any paper towels which would indicate that the restrooms were probably not stocked in the morning and that perhaps the school may been out of their supply of paper towels even before the day of the inspection. As such, please ensure that measures are in place to ensure that the school is provided adequate supplies of sanitary supplies including paper towels at all times. GDOE has been well informed that sanitary supplies must be made available at all times during the school day. The absence of paper towels in every restroom is unacceptable and should be addressed and rectified immediately. Frequent monitoring of the restrooms is highly recommended to ensure that each restroom is properly maintained, cleaned regularly, fully operational, and stocked at all times with toilet paper, soap, and paper towels or functional hand-air dryers.

Please submit to my office, in writing, GDOE's efforts to rectify each of the discrepancies identified in the inspection report, including but not limited to measures taken or to be taken to rectify each discrepancy and a proposed date when such discrepancy was rectified or would be rectified.

Girls gym shower room: toilet clogged. Annex girls restroom 1st floor: Two toilets leaking.	Restroom fixtures are required to be kept clean and in good repair at all times.	Address and rectify all discrepancies immediately in order to come into compliance with the law. Reports of water leaks and/or other fixture leaks should be addressed and rectified immediately. GDOE must work to respond to reports of fixtures in disrepair in a timely manner in order to prevent waste of resources and to ensure each restroom remains clean, safe, and in a sanitary condition.		
	Fire extinguishers	1	S	9/1310	N/A	Observed fire extinguisher annual service identification tag has expired.	The annual service identification tag indicates that the extinguisher was last serviced in August 2009 and that it expires 12 months from that date. In other words, this particular fire extinguisher expired in August 2010. Fire extinguishers require annual servicing by a properly licensed party. Monthly monitoring of the fire extinguishers should be performed by school personnel.	Require school officials to examine each fire extinguisher to verify that the annual service date has not expired. All fire extinguishers that are expired should be re-serviced immediately. Monthly monitoring of the fire extinguishers would enable the school to ensure that the fire extinguishers are properly serviced. The DOE Safety Office should develop a master list of all the schools, log the annual service dates for all fire extinguishers, and provide reminders to school officials in advance of the annual service expiration date of any such fire extinguishers. In addition, the DOE Safety Office should coordinate with the fire extinguisher well in advance of the expiration date of the fire extinguishers or when fire extinguishers are reported in disrepair in order to ensure that a sufficient amount of properly working fire extinguishers are available in the schools. Proper planning and scheduling should be a priority concerning the availability of working fire extinguishers to ensure that student safety is not compromised.
