

Re: Public Law 30-196 (FY2011 Budget Act) Transfer Authority for the Office of the Attorney General Modification No. ModAG11-001)

Dear Governor Camacho and Speaker Won Pat:

Public Law 30-196 permits the Office of the Attorney General to transfer between object class allocation provided notification to the Governor and Speaker of the Guam Legislature is made at least fifteen (15) days prior to such modification.

The transfer is necessary to provide the sufficient funding for certain object class categories that the original appropriation did not cover such as the contractual services and travel for expert witness/defendants, and drug test fee for recruitment of attorneys or staff who have resigned and/or retired. These services also include but are not limited to Special Prosecutor, Expert Witness, Deposition requests, and so on which are crucial to the Office's operations.

Therefore, the modification of our object class categories will occur as prepared in the attachment.
