fiscal year budget (Not no of PPE). Cash received as of August 31, 2010, is \$24.4M. Therefore, GovGuam is \$5.6M in arrears for FY10 allotmen

b. \$ 2.34M increase in net assets using ACCRUAL BASIS, but \$3.3M decrease using CASH BASIS of GovGuam appropriations.
