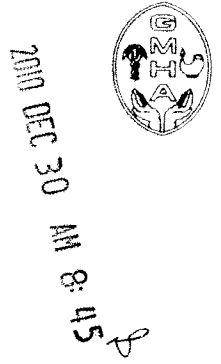

WHEREAS, Public Law 26-66, places the rate making authority of the Guam Memorial Hospital Authority under the GMHA Board of Trustees; and

WHEREAS, the GMHA Board of Trustees has reviewed the Public Law 26-66; and

WHEREAS, a Public Hearing was held on December 10, 2010 and oral comments and written testimony have been solicited for the One Hundred Seventy-Two (172) new fees comprised of the following Hospital departments: Emergency Room, Central Supply Room, Radiology, Pharmacy and Operating Room; and

WHEREAS, the Board of Trustees Finance & Audit Committee met on December 14, 2010, reviewed and recommended that the Board of Trustees approve the One Hundred Seventy-Two (172) new fee items; and

WHEREAS, the Board of Trustees has reviewed the list of new fees and found the same to be in order; and


WHEREAS, the Hospital has realized Fifty-Two Thousand Five Hundred Fifty-Two and Cents Ninety-Nine (\$52,552.99) in revenues since the inception of the new fees; now therefore be it,

RESOLVED, that the Chairperson certifies and the Secretary attests to the adoption of this resolution.



MINUTES

In accordance with the Administrative Adjudication Law, a public hearing was held on Friday, December 10, 2010, at 9:30 a.m. in the GMHA Daniel L. Webb Conference Room, to solicit public opinion on the Hospital's 172 new fees.

Present were: (Refer to Exhibit 10 – Attendance Sheet).

Note: Copies of the Public Hearing Agenda (Refer to Exhibit 9) and the Listing of New Fees (Refer to Exhibit 3) were made available to all attendees.

I. Introduction

Ms. Jane B. Flores introduced herself as the Presiding Public Hearing Officer for this public hearing. Our public hearing recorder was Ms. Candy Chan. The public hearing was now commenced at 9:33 a.m.

II. Opening Remarks

On behalf of the GMHA Board of Trustees, the Hospital Administrator/CEO, and the GMHA employees, Ms. Flores welcomed the public for attending the public hearing. She stated that we would generally provide a grace period for the public to find parking in order to attend this hearing. We would reconvene the hearing in ten to fifteen minutes.

Ms. Flores announced to reconvene the public hearing at 9:45 a.m. and presented the purpose of this public hearing.

III. Purpose of the Public Hearing

The enactment of Public Law 26-66 in December 2001 removed the rate-setting jurisdiction from the PUC and gave it to the GMHA Board of Trustee: It was referenced under 10 GCA §80105 entitled "Hospital Rates". Ms. Chan would provide a copy of the mandate upon request.

Ms. Flores indicated that the Hospital had a total of twenty-nine (29) public hearings during fiscal years 2002 through 2010. A total of 3,672 new fees/services and 2,181 rate increase fee items had been introduced and adjudicated.

In compliance with the Administrative Adjudication Law and further Guam Code Annotated directives, the Hospital did publish in the Pacific Daily News and Marianas Variety the announcement of this public hearing (Refer to Exhibit 5 – Notice of Public Hearing) and distributed the Notice of Public Hearing to all Hospital departments and units and also posted in public areas throughout the Hospital.

The Hospital also sent the Notice of this Public Hearing via facsimiles to various news media organizations, the Governor's Office, the Congressional Representative, and to our elected Senators of the 30th Guam Legislature (Refer to Exhibit 6 – GMHA Fax Confirmations of Notifications). In addition, letters were also sent to the Third Party Payers with the listing of new fees inviting them to this public hearing (Refer to Exhibit 7 – Letters inviting Third Party Payers to Public Hearing).

The Hospital also posted the Notice of Public Hearing on its official website as mandated by public law and the website is www.gmha.org (Refer to Exhibit 8 – Press Release displayed on GMHA website).

At this time, Ms. Flores would like to introduce Mr. Luis Miclat who would do the presentation of the new fees today.

IV. Presentation of Summary of New Fee Items

Mr. Luis Miclat introduced himself being in charge of the Charge Master Library. He stated that we were presenting today a total of one hundred seventy-two (172) new fee items submitted by various departments of the Hospital for the past three months. The summary of these new fee items/services were as follows:

V. Testimonies from the Public

At this time, Ms. Flores would like to solicit from the public if they had any testimony in relation to the new fees presented at this public hearing. She also stated that the public could submit a written testimony within five (5) days after this public hearing. These testimonies would be incorporated into the submission package to the 30th Guam Legislature, subsequent to the approval by the GMHA Board of Trustees.

VI. Questions and Answers on the Proposed New Rates, Fees and Charges

At this time, Ms. Flores would like to solicit from the attendees if there were any questions concerning the new fee items presented today at this public hearing.

Mr. Anthony Mendiola of StayWell Insurance inquired how the new fees were developed and the type of source used to develop the fees. Mr. Miclat responded that upon receiving the fee schedule submission from the departments, he would input the necessary requirements with calculations and run the fee program that was approved by the BOT. This program would generate and assign the price for the fee item. Ms. Flores added that our new rate setting model is based on actual cost structure of the Hospital. We also have the annual Medicare Cost Report that compiled all the costs of the Hospital.

Mr. Mendiola also inquired about the components of the new fees and how the departments based their submitted requests to define the technical component charges. Mr. Miclat responded that the departments would base on the actual salary and the length of the procedures and used a formula to determine the particular number to put in the system. Ms. Flores added that the salary is based on the GovGuam pay schedule and that there would only be the time spent by the medical and clinical staff involved in the procedure. No administrative cost would be added.

Mr. Frank Campillo of Selectcare referred to the Emergency Room Immunization fee services on the listing and inquired what type of immunization is needed in the Emergency Room. Mr. Miclat responded that it would be on case basis according to the patient's records and the doctor's discretion providing the orders. Mr. Campillo commented that the Hospital is not a primary care facility. To avoid losing money, as an outpatient facility, the Hospital does not necessarily provide preventive vaccine to those patients who do not have insurance and should direct those patients to other private clinic or public health.

Mr. Steve Baacke stated that from a clinical standpoint, the Hospital is trying to perform standard care as other hospital's emergency room does. Mr. Campillo indicated that it should depend on what type of vaccine we should provide. Ms. Flores noted that she would request the first four items on the new fee listing in relation to immunization be reconsidered.

Mr. Mendiola inquired if the Hospital had actually provided services the department requested, such as Radiotherapy Plan and IMDR. Mr. Miclat responded that we would just have some of the services ready in time when the interventional radiologist arrives to perform those services and the charge codes for those procedures would already be in place.

Mr. Campillo expressed his concern on how the Hospital handled patients for radiology services in the absence of Radiologist. He indicated that the doctors discharged the patients and referred to Guam Radiology Consultant for examination. When the radiological problem was identified, the patients were re-admitted to the Hospital. He indicated that Selectcare would not pay for such discontinuity of care and was a violation in protocol. The Hospital should not charge the insurance for inefficiency. Mr. Baacke indicated that we actually have someone reading the film while Dr. Young was off-island, Mr. Campillo suggested that we fix the problem at point of billing cycle. Ms. Flores would work with the Billing Office to correct the situation.

Mr. Mendiola stated that according to their claim form, certain Hospital fees were not available on our website. Mr. Miclat would look into it and would update the fee schedule on our website. Mr. Campillo suggested the Hospital provide the updated fee schedule to the insurance companies on a quarterly basis.

There were no other questions followed.

VII. Closing Remarks

In closing, Ms. Flores thanked everyone for making the time in their busy schedules to attend this public hearing. Ms. Flores expressed her appreciation on the public input, especially from the insurance side.


VIII. Adjournment

Ms. Flores called the hearing to adjourn at 10:03 a.m., December 10, 2010.





Badgers on verge of Rose Bowl nod

Wisconsin is on the verge of its first trip to the Rose Bowl since January 2000 after the Badgers remained ahead of Ohio State and Michigan State in the latest BCS standings.

Those three teams tied for the Big Ten title, and the BCS standings are used to break that deadlock. Wisconsin was No. 5 Sunday, with Ohio State one spot behind and Michigan State No. 8.

The final BCS standings come out next weekend, but it's hard to imagine either of the other teams moving ahead of Wisconsin now that all three have finished their regular seasons.

"It's kind of hard to make that up in a week when nobody's playing," BCS analyst Jerry Palm said.

Theoretically, Wisconsin could still move into the top two and end up in the BCS championship game, but that's an extremely far-fetched scenario that would have to include losses by both Auburn and Oregon next weekend.

Rose Bowl, the other two co-champions will be left to fight for an at-large spot in a BCS bowl. If the higher-ranked Buckeyes are offered a BCS invitation, the Spartans would presumably play in the Capital One Bowl.

Boise State falls to No. 9

NEW YORK (AP) — Boise State dropped six spots to No. 9 in The Associated Press college football poll after having its 24-game winning streak snapped.

For the third straight week, No. 1 Oregon and Auburn hold the top two spots in the rankings. No. 3 TCU moved up one spot.

The gap between the Ducks and Tigers shrank to

19 points. The Ducks have 36 first-place votes and 1,475 points, while Auburn has 23 and 1,456 from the media panel.

Wisconsin is fourth and Stanford is fifth.

Boise State had been ranked no lower than fourth this season, but after losing 34-31 in overtime to Nevada, the Broncos tumbled out of the national championship race.

Federer beats Nadal in finale

LONDON (AP) — Roger Federer gave Rafael Nadal little chance to mount a challenge in the 22nd meeting between two of the greatest players of all time, winning his fifth season-ending title 6-3, 3-6, 6-1 at the ATP World Tour Finals on Sunday.

Federer won an incredible 92 percent of the points played on his first serve in the final, and lost only 13 points on serve in the entire match.

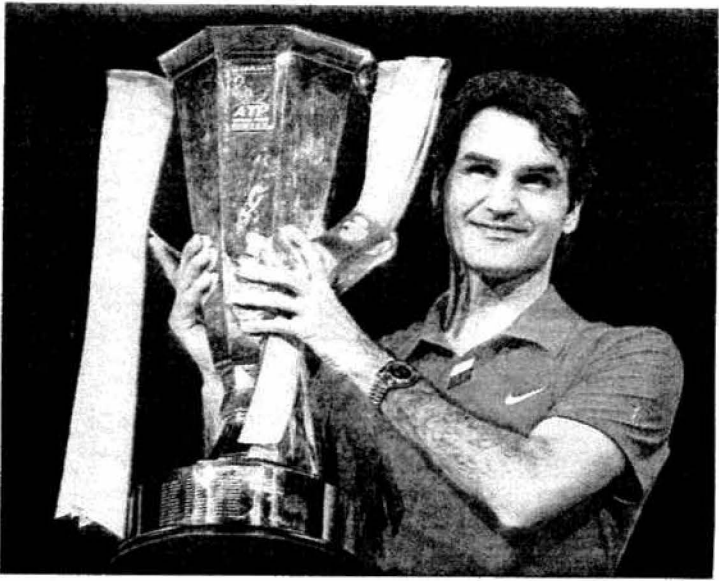
Nadal, the top-ranked Spaniard who won the French Open, Wimbledon and the U.S. Open this year, was able to break Federer once in the second set, but he appeared to tire as the match wore on. On Saturday, Nadal spent more than three hours and three sets beating Andy Murray to reach the final of the tournament for the first time in his career.

"I know I didn't spoil his vacation after this because he's had an amazing year," Federer said. "A year that any player dreams of."

The win cut Nadal's career record to 14-8 against the second-ranked Swiss player. In Grand Slam finals, Nadal is 5-2 against Federer, but Federer has now beaten Nadal all three times they have faced each other in the final tournament of the season.

Serving up winners

In the first set Sunday at the O2 Arena, Federer lost only three points on his serve, and broke Nadal once. He then lost five points on serve in both the second and third sets, but four

of them came in one game, giving Nadal his only break of the match.

The decisive shift came early in the third set on Nadal's serve with the Spaniard trailing 1-2. He took a 40-15 lead when Federer sent a return long, but Federer then reeled off the next four points — the last when Nadal sent a forehand wide — to earn the break and essentially end Nadal's

chances of winning.

On match point, Federer hit a forehand winner on the line, but the crowd apparently thought the ball was out as they sat quietly in the arena. Then Nadal started coming to the net to shake hands with Federer, who raised his arms in victory to set off a standing ovation.

Federer has won a record 16 Grand Slam titles, the last coming at this year's Australian Open, and he and Nadal

have combined to win 21 of the past 23 majors.

But after ending his semifinal streak at major championships at Roland Garros and then faltering at the last two Grand Slam tournaments, Federer has played some of his best tennis of the year this week in London.

He won all three of his round-robin matches in straight sets, and then swept Novak Djokovic on Saturday to reach the final.

The Evergreen audit also recommended that DOE consider an increase in its school lunch program.

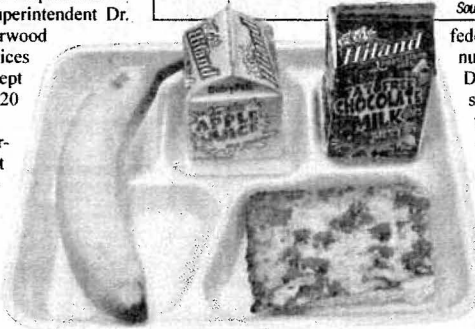

§ 10306. Information Required on Official Home Pages.

The following information is required to be posted on each Official Home Page for each Branch of the government of Guam:

Notice of Meetings and Public Hearings.
