AN ACT TO REZONE LOT NO. 3 OF TRACT 1419, LOCATED IN THE MUNICIPALITY OF *DEDEDO*, FROM AGRICULTURAL ZONE (A) TO COMMERCIAL ZONE (C).

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that it is the desire of the owners of Lot No. 3 of Tract 1419, which fronts Tun
- 4 Columbo St. (Alegeta Road) in Macheche, to own and operate a mom-and-pop
- 5 store for the retail sale of food and other general merchandise.

I Liheslaturan Guåhan further finds that the owners propose to utilize the two thousand four hundred fifty (2,450) square foot first floor of the existing two-story building located on the property for the operation of a convenience store.

Therefore, to assist the owners in servicing those who live and commute the *Macheche/Alegeta* road vicinity, *I Liheslaturan Guåhan* intends to authorize the rezoning of the lot described herein for the operation of a mom-and-pop store.

Section 2. Lot Rezoning. Notwithstanding any other provision of law, Lot No. 3 of Tract 1419, containing an area of one thousand eight hundred sixtyone (1,861) +/- square meters, and located in *Macheche* in the municipality of *Dededo*, is hereby rezoned from Agricultural Zone (A) to Commercial Zone (C).

Section 3. Effective Date. This provisions contained herein *shall* take effect upon enactment of this Act.

Section 4. Severability. *If* any of the provisions of this Act or the application thereof to any person or circumstance is held invalid, such invalidity *shall not* affect any other provision or application of this Act which can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.
