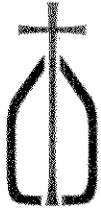

ANNUAL REPORT**

October 1, 2012 to September 30, 2013

ALEE SHELTER FOR ABUSED WOMEN:

In fiscal year 2013 we served fifty-eight (58) unduplicated adult clients and ten (10) are returning clients from previous years.

Ethnicity breakdown is as follows:

These statistics rate Chamorro as the largest group recorded. ^{over}Chuukese ethnicity ranks second, Filipino ethnicity ranks third, all other groups fall below five on the family violence admittance into the shelter.

Of the total number of women received at the women's shelter, there were three (3) women sexual abused, four (4) physical abused, forty (40) both Physical & Emotional abused, nine (9) emotional abused, and two (2) did not indicate type of abuse.

Situation: One (1) rape case, two (2) women pregnant, one (1) SCC – Special Circumstance Client and Fifty four (54) were emergency cases.

Marital status is as follows:

Amongst the marital status category, Single women group rank the highest for this period, followed by married women. There were some that were admitted into the shelter but only did one day stay or overnight because they decided to leave or stay elsewhere.

The ages of the women range ^{from} ~~from~~ eighteen (18) to sixty (60). Within this range, the breakdown is as follows:

Number of children served this year was eighty-six (86), 49 boys, and 37 girls. The ages of children spanned the entire range of eligibility in the women's family violence shelter, from newborn to seventeen years.

Referrals continue to come from various community agencies as well as former clients, friends and professionals in the community. Outreach effort at local malls, and community functions have positive impact, as the showing of informational calls increase. Women are seeking a means to remove themselves from the threat, the fear and dependency.

A permanent Family Violence Shelter was completed in 2012. The project was made possible through Guam Housing and Urban Renewal Authority (GHURA) Community Development Block Grant.

A great deal of networking with other agencies who are involved in the assistance of abused women, persist in excellent working relationship with Guam Legal Services Corporation, the Public Defenders Office, Crime Victims Advocates of GPD and Victims Advocates Reaching Out (VARO) as well as local government agencies. Alee Shelter operates under funding from Bureau of Social Services Administration (BOSSA) The Department of Public Health, STOP Violence Against Women Act Grant and Sexual Assault Services Program Grant through the Governor's Community Outreach Federal Programs Office, Victim of Crime Act (VOCA) through the Office of the Attorney General.

ALEE TRANSITIONAL HOUSING

We served four (4) unduplicated adult clients for this year.

Number of children served this year was eight (8), 5 boys and 3 girls. The ages of children spanned the entire range of eligibility from three to thirteen years.

Referrals came primarily from Alee Shelter for Abused women. Department of Justice Office of Violence against Women Grant continues to provide funding for this program that is directly administered by Catholic Social Service.

ALEE SHELTER CHILDREN'S SHELTER

Forty-five 46 children have gone through the doors of Alee Shelter. Fourteen (14) unduplicated clients, thirty-two (32) children left the shelter. Also this number includes siblings that have been with us since 2008. The caseworkers have difficulty in location foster homes for the Alee Children. The children range in age from newborn to seventeen (17) year of age. The ethnicities of the children are follows:

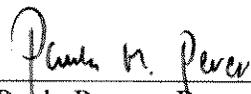

This year Alee had encountered a sudden turnover of clients and staff. Necessary adjustment of staff scheduling were in place to accommodate the client and shelter needs. The program manager continues to address the status of overstayed children with their respective caseworkers. Despite the constant challenges, the program encourages new and seasoned staff to attend various training courses available in order to keep abreast of new information and techniques in working with abused /neglected and physically challenged children. Adjustment on the children's part is balanced with the care, compassion and as close to the home environment as possible for stability.

Alee shelter continues to receive several donations from the military, civic associations and local business. We are blessed with continuing strong community support in donations. Staff and children outing are provided during the summer months and throughout the year so that the children would get the proper exercise for healthy living. All these activities contribute to the children's self-esteem along with the enhancement of their social skills.

Funding comes from the Bureau of Social Services Administration (BOSSA) The Department of Public Health and from the VOCA Grant administered by the Attorney General Office. Catholic Social Services manages these funds.

The program continues to seek other source of funding for the program's clients activities.

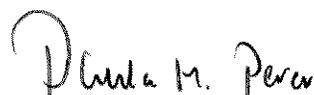

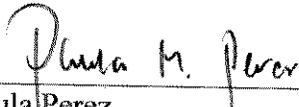

The program manager position was filled by Juliet Barroga in an acting capacity. Interview where held for Social Worker and Administrative Assistant. The social worker position was filled by Jeraldyn Deseo and the Administrative Assistant position was filled by Louise Cruz.

Alee I Catherine's Home Family Violence Domestic Shelter

Catherine's home – Alee I Family Violence Domestic Shelter had a usual busy month. A total of eighteen (18) Women and thirty two (32) children were served by the end of quarter, eleven (11) women were discharged from the program. We have some challenges on client's behavior but have been smoothing out with the help of GPD and Advocates involved. However, our intake of client has increased, but we will strive to give the clients our unconditional support and give our utmost dedication in serving abused women and children that knock on our door.

Client 2175 was admitted to the shelter on August 20, 2013 utilized the Alee Shelter Program, for a shelter and a safe home. The client refused to apply for a Protective Order but requested to stay until the room at her mother-in-law's house was available; she is discharge from the shelter on September 13, 2013.

Client 2179 refused to apply for a Protective Order. She is convinced that she is safe to return home. She signed a release form upon her exit interview she was discharge September 18, 2013.

Client 2183 was admitted for a night on September 23, 2013 but insisting in returning home, she was transported to GPD – Agat Precinct the next day due to the request of GPD for further investigation, allegedly she was also in fault the night of the incident. GPD informed the Alee Program Manager that the client might be arrested. The client was discharge from the shelter the same day.

Client 2177 admitted into the shelter on September 5, 2013. Alee Shelter staff accompanied her the next day to Guam Legal Service to apply for a Protective Order; however client was more concerned about custodial rights for her children. She refused to secure a Protective Order and decided to leave the Shelter and go back to her apartment because she indicated that she is safe and comfortable in her apartment. Alee Shelter Staff had discussed safety issues with her, but client insisted she'd be okay in her apartment. Discharge form was sign by the client.

Client 2178 and 2180 was admitted to the shelter September 14, 2013. They were accompanied by Alee Shelter staff to Guam Legal Service on September 26, 13. They meet with the attorney on September 26, 2013; they are still waiting to their Protective Order conformation.

2184 admitted to the shelter on September 27, 2013, client refuses to apply for Protective Order and was discharge on September 30, 2013 due to client request.

Client 2176 was admitted to the Shelter on September 2, 2013. Alee staff accompanied the client to Guam Legal Services and applied for Protection Order, however she was denied due to the circumstances that the client presently under Child Protective Services case. Guam Protective Service referred client to the Public Defender Service. She was also denied services at Public Defender office due to the conflict of interest. Client then applied through the Superior Court as a Pro-Se and was given her Protective Order on September 12, 2013. She is working on her personal plan to gain independency.

2181 client attended her Court Hearing on September 27, 2013. The Court Order is for the client to undergo counseling services with Dr. Kirk Bellis, for her to avail visitation with her children again.

Client 2182 refused to apply for a PO she claimed her life was not in danger because her husband would be too busy taking care of his daughter who was dying of cancer. Another client at shelter

filed assault charges against her on September 24, 2013 at GPD- Dededo Precinct. She was then held there for further questioning. Her son was taken from her and returned to her husband, as he has court order, as primary parent. Referring program (GPD-VAU) had found out that she had other Family Violence cases where she was listed as the aggressor.

Client 2078-1 and 1436-2 are repeat victims, two of them along with client 2185 wants to apply PO, which is in the process.

Transitional Housing

Three no-cost, safe and secure two –bedroom apartment units are rented under the Alee Shelter’s TH Program (Grant No. 2011-WH-AX-0005.) All three clients and four children were referred through the Alee Family Violence Domestic Shelter and are being served.

On January 04, 2013 the client entered the program and has full custody of her minor child. She is still employed and attends the Guam Community College. She had some minor set backs with her car, as her care was leaking oil from the engine. The Social Worker completed a home assessment on September 25, 2013. Client expressed happiness, as she was able to find her biological father. Client has been looking for her father since she was six years old. It has been twenty-two years since she last spoke to her father. Client’s father has been incarcerated and client has not been able to find him until recently. Client completed Domestic Violence Personalized Safety Plan.

On July 9, 2013 the client that entered the program has one child. Client is a single parent to an eleven year old son. Client spoke to Social Worker (SW) about the dryer not working. SW contacted Realty to inform about the dryer. Realty Agency stated that maintenance will conduct an assessment on September 9, 2013. This information was relayed to client. SW informed client that she has a responsibility to report any maintenance issues to Realty Agency and Transitional Program. Client continues to maintain cleanliness and upkeep of living space, furniture, and appliances.

The client that entered the program on August 27, 2013 has two children. Client received services from Alee Shelter in July 2013. Client received authorization letter from Realty Agency to apply for cable and internet. The client’s *Financial Plans* are (1) to complete monthly budget by figuring out expenses and to follow-up on food stamp. As of September 26, 2013, client met second goal. The Client’s *Employment Stability Goals* is to (1) maintain employment by attending work as scheduled. Client is currently employed full time and has been with the same employer since September 2012. Client Housing Stability Goals is secure permanent/public housing by requesting, submitting, and following –up on the application. Client’s application from Guam meet this goal is October 2013. Client’s Other Goals are to get an application from

Guam Community College for college and vocational training. Client's target date to meet this goal is November 2013. In addition, client is seeking counseling for her children.

Transitional Housing units:

- Unit B1: Maintenance required at this time.
- Unit B5: Client reported on September 17, 2013 to SW that the toilet is leaking and the air con in one of the rooms is not working. SW followed on September 20, 2013 with Realty Agency about maintenance for repairs.
- Unite B7: No Maintenance required at this time.

The women in the Transitional Housing maintain the cleanliness of their living space, furniture, and appliances. These women are moving forward to healthier and fruitful life style.
