



Buenas! This is to request for your approval for Emergency Procurement to ensure the continuation of Title III Nutrition Services more commonly referred to as the Elderly Nutrition Program (ENP). Congregate (C1) and Home-Delivered Meals (C2) that are being provided by S.H. Enterprises. Inc. through an emergency procurement to expire on Friday, March 29, 2013.

The Elderly Nutrition Program ensures the provision of a hot, nutritious meal that provides a minimum of 33 and 1/3 percent of the current Recommended Dietary Allowance, as established by the Food and Nutrition Board of the National Academy of Sciences. National Research Council to seniors who access one of the 14 congregate meals sites or those who have been determined by our Case Management Services program to be homebound. The Congregate component or C1 of the ENP provides for approximately 731 seniors while the Home-Delivered component or C2 provides for approximately 1.144 homebound seniors, a combined total of approximately 1.875 seniors. For many seniors who access this meal service, this is perhaps the one balanced meal they will receive on any service day of this program.

The procurement of these services through an Emergency Procurement under 5 G.C.A. §5215 is necessary in order to avert a threat to the health, welfare and safety of our seniors who rely on this meal at either the 14 designated congregate sites or at their home.

The Department of Public Health and Social Services (DPH&SS), Division of Senior Citizens (DSC) is working with the General Services Agency (GSA) to procure these services through the Invitation for Bid (IFB) process. Attached is the announcement published in the Marianas Variety on March 22, 2013 (today), for IFB GSA-036-13 for ENP C1 which is found on page 15 and IFB GSA-059-13 for ENP C2 found on page 4.
