NOTE:

1. As of 09/31/12, DOE received a total remittance from DOA in an aggregate amount of \$198,753,577 over a period of 12 months of operations.

2. It appears that DOA is remitting a monthly fund \$16,533,764 to DOE.

3. Of the total approved budget of \$202,533,762 (PL 31-75), DOE received a total amount of \$198,405,171, thus leaving a balance of \$3,780,185, which is equivalent to only 1.87% Reserve.
