Dear Counsel, Madam Speaker, Sen. Pangelinan, and Friends:

The attached Order was received today from the Ninth Circuit, modifying the due dates for filing of the court reporter's transcript and briefing in Dave Davis' appeal of the order dismissing his challenge to the "Native Inhabitants Only" Plebiscite law, moving everything another 30 days into the future as follows:

- Appellant Dave Davis' opening brief is due July 15, 2013;
- Appellee GovGuam's answering brief is due August 14, 2013;
- Appellant's optional reply brief is due within 14 days after service of the answering brief.

Based on recent experience and the Ninth Circuit's own calculations in other cases (see http://www.ca9.uscourts.gov/content/faq.php, FAQ 17 and 18), we could be looking at another year to 18 months after briefing is completed before oral argument is scheduled, and another three months to a year after that before a decision is rendered. As briefs are filed I will forward copies.
