AN ACT TO REZONE LOT 2181-4NEW-R1NEW-R2, LOT 2181-4NEW-R1NEW-2, LOT 2181-4NEW-1-1, LOT 2181-4NEW-1-2, LOT 2181-4NEW-1-3, LOT 2181-4NEW-1-4, LOT 2181-4NEW-1-R4 AND LOT NAVAL AIR STATION AGANA-21-R1 (AIRPORT PARCEL 4) IN THE MUNICIPALITY OF TIYAN, BARRIGADA AGRICULTURAL ZONE (A) TO LIGHT INDUSTRIAL ZONE (M1); AND TO AMEND §61201 OF ARTICLE 2, **CHAPTER** 61 **OF** TITLE 21, **GUAM** CODE ANNOTATED. RELATIVE TO **CHANGING** THE REFERENCE OF "M1 LIMITED INDUSTRIAL ZONE" TO "M1 LIGHT INDUSTRIAL ZONE."

Section 1. Legislative Findings and Intent. It is the desire of I 1 Liheslaturan Guåhan to maintain consistent development and use of land to 2 3 promote the highest and best use of Guam's lands, one of our most important 4 assets. I Liheslatura finds that the passage of Public Law 31-198 caused all 5 federal excess land that were returned to original landowners to be designated 6 as Agricultural Zone (A). However, many of these lands as returned were 7 already in use for purposes other than Agricultural Zone (A), such as schools, 8 construction staging areas, warehouses, and offices, which more appropriately 9 fits the designation of Light Industrial Zone (also known as Limited Industrial 10 Zone). It is the intent of I Liheslaturan Guåhan to allow the use of the lots 11 described herein to continue without interruption.

- Section 2. Lots to be Rezoned. The following lots: Lot 2181-4NEW-13 R1NEW-R2, Lot 2181-4NEW-R1NEW-2, Lot 2181-4NEW-1-1, Lot 2181-4NEW-1-2, Lot 2181-4NEW-1-3, Lot 2181-4NEW-1-4, Lot 2181-4NEW-1-R4 and Lot Naval Air Station Agana-21-R1 (Airport Parcel 4) are hereby rezoned from Agricultural Zone (A) to Light Industrial Zone (M1).
- Section 3. Change of Reference. The reference to "M1 Limited Industrial Zone," as found in §61201 of Article 2, Chapter 61 of Title 21, Guam Code Annotated, is hereby *amended* to read: "M1 Light Industrial Zone."
- 20 **Section 4.** This Act *shall* become effective upon enactment.
