

AN ACT TO *REPEAL* AND *REENACT* §9108 OF CHAPTER 9 OF TITLE 16, GUAM CODE ANNOTATED, RELATIVE TO CHANGING THE PENALTY FOR VIOLATION OF THE TRAFFIC CODE FROM A PETTY MISDEMEANOR TO A CIVIL VIOLATION PUNISHABLE BY A FINE.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. §9108 of Chapter 9, Title 16, Guam Code Annotated, is hereby
- 3 *repealed* and *re-enacted* to read:

"§ 9108. Violation of This Title – Violation.

(a) *Except* in cases where a different punishment is provided by this Title or other law, every person who fails or refuses to comply with or violates any provision of this Title is guilty or liable of a civil violation punishable by a fine *not to exceed* Five Hundred Dollars (\$500.00).

5 (b) Notwithstanding Subsection (a) of this Section, the Office of 6 the Attorney General is *not* precluded from filing a criminal complaint or 7 indictment, pursuant to Chapters 15, 45 and 50 of Title 8, Guam Code 8 Annotated, in the Superior Court of Guam that *may* include charges 9 involving the violation of, or failure or refusal to comply with any provisions 10 of Title 16, Guam Code Annotated."
