AN ACT TO AMEND SECTION 2 AND SECTION 3(b), AND TO ADD A NEW SECTION 4 OF PUBLIC LAW 24-33, RELATIVE TO AMENDING THE LICENSE AGREEMENT BETWEEN THE GUAM FOOTBALL (SOCCER) ASSOCIATION AND THE GOVERNMENT OF GUAM.

BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. *I Liheslaturan Guahan* finds 3 that the Guam Football (Soccer) Association (GFA) has continued to show they 4 have been good community partners and supportive of the growth of soccer on 5 Guam for all ages. This is evident by the construction of first-class soccer fields



6 and other facilities at the Guam *Dededo* Sports Facility, and their plans to expand 7 to the southern part of the island.

I Liheslaturan Guahan further finds that Public Law 24-33 authorized I 9 Maga'lahi (the Governor) to enter into a lease agreement for GFA to build its 10 facilities and provided a portion of property, described as Lot 10142 NEW, Tract 11 100, *Dededo*, Guam. Since the execution of the license agreement, the property has 12 since been subdivided and the area in which the GFA currently utilizes for its 13 facilities is identified as recorded map No. 085FY2009, Document #788675, Lot 14 10142-NEW-4, with an area of seventy-nine thousand five hundred ninety-six plus 15 or minus (79,596+/-) square meters.

16 It is, therefore, the intent of I Liheslaturan Guåhan to amend the license agreement between the government of Guam and the GFA to reflect the recorded 17 map description, and to allow a renewable clause for the terms of the license 18 19 agreement.

20

Section 2 of Public Law 24-33 is hereby *amended* to read: Section 2.

21 "Section 2. I Maga'lahi is authorized to establish, through the 22 Department of Land Management, a regulation-size soccer stadium and 23 related facilities of no less than seventy-nine thousand five hundred ninetysix plus or minus (79,596+/-) square meters of land area, located within the 24 25 boundaries of Lot No. 10142-NEW, Dededo, consisting of two hundred forty-two thousand six hundred ninety-four plus or minus (242,694+/-) 26 27 square meters."

28

Section 3(b) of Public Law 24-33 is hereby *amended* to read: Section 3.

29 "(b) The license agreement between the Department of Parks and Recreation and the Guam Football (Soccer) Association shall hereby be 30 amended and shall identify the specifics of seventy-nine thousand five 31 32 hundred ninety-six plus or minus (79,596+/-) square meters, as identified in



33 the recorded map No. 085FY2009, Document #788675, Lot 10142-NEW-4,

34 which *shall* be the subject of the management and operating agreement."

35 Section 4. A new Section 4 is hereby *added* to Public Law 24-33 to read
36 as follows:

37 "Section 4. Notwithstanding any other provision of law, the term of
38 the lease *shall* be renewable every thirty (30) years."

39 Section 5. Effective Date. This Act *shall* be effective upon enactment.

40 Section 6. Severability. *If* any provision of this Law or its application to 41 any person or circumstances is found to be invalid or contrary to law, such 42 invalidity *shall not* affect other provisions or applications of this Law which can be 43 given effect without the invalid provisions or application and to this end the 44 provisions of this Act are severable.
