
AN ACT TO *ADD* A NEW § 8107.1 AND A NEW SUBPART (C) OF § 8104(a)(5), AND TO *AMEND* SUBPART (A) OF § 8104(a)(5), ALL OF CHAPTER 8 OF TITLE 5, GUAM CODE ANNOTATED, RELATIVE TO THE CREATION OF THE "GUAM PUBLIC NOTICE WEBSITE."

BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. A new §8107.1 is hereby *added* to Chapter 8 of Title 5, Guam

3 Code Annotated, to read as follows:

be easily accessible by the public from the government of 1 (5)Guam and Guam Legislature home pages; 2 have a unique and simplified website address; 3 (6)be directly accessible via a link from the main page of the 4 (7)5 official government website; and 6 (8)include other links, features, or functionality that will assist the public in obtaining and reviewing information in relation to 7 public notices posted on the website, as may be approved by the 8 9 Department of Administration. The Department of Administration *shall* be responsible for: 10 (e) 11 (1)establishing and maintaining the website, including the 12 provision of equipment, resources, and personnel as is necessary; providing a mechanism for public agencies to have 13 (2)access to the website for the purpose of posting and modifying 14 15 notices; and maintaining an archive of all notices posted to the (3)16 website. 17 The time period for posting and the content of the public 18 (f)notices posted to the website *shall* be the responsibility of the public agency 19 or other entity posting the notice. The agency or entity posting or publishing 20 the public notice required under this Section must meet all the requirements 21 22 for public notice under the Open Government Law." 23 Subpart (A) of §8104(a)(5) of Chapter 8 of Title 5, Guam Code Section 2. Annotated, is hereby *amended* to read as follows: 24 "(A) Public Notice, as used in this Chapter, means a publication by 25 newspaper of general circulation or by radio or television which is 26 reasonably calculated to provide notice of the facts it announces to the 27



public at large, *and* by electronic publication on the Guam Public Notice
 Website."

3 Section 3. A new Subpart (C) is hereby *added* to §8104(a)(5) of Chapter
4 8, Title 5, Guam Code Annotated, to read as follows:

5 "(C) Government entities that access cable channels *shall* also be 6 required to broadcast public notices on that channel for that respective 7 branch of government."

8 Section 4. Effective Date. This Act *shall* be effective 180 days after
9 enactment.
