**ORDER**  
re Site Visit

At the last Quarterly Status Hearing, the Receiver reported that the Closure Plan required acquisition of several lots adjacent to the Ordot Dump site, as well as renovations to Dero Road. As we approach the finish line to the closure of the Ordot Dump, the court believes it would be beneficial to conduct a site visit for the purpose of viewing these affected properties and Dero Road. The court also intends to visit the bridge and road projects along Route 4 which affect the Consent Decree in order to observe the status of the projects that remain, as well as visit the Layon Landfill Municipal Solid Waste Facility to view operations. The site visit shall commence at the Ordot Dump on July 5, 2013, at 1:30 p.m. The following individuals are ordered to attend:

- Hon. Raymond. S. Tenorio, the Lt. Governor of Guam;
- Hon. Judith T. Won Pat, Speaker, 32nd Guam Legislature or, in her absence, Hon. Benjamin J.F. Cruz, Vice-speaker, 32nd Guam Legislature;
- Hon. Thomas C. Ada, Senator, 32nd Guam Legislature, Chairperson of Committee on Public Safety, Infrastructure & Maritime Transportation;
- Carl V. Dominguez, Director, Guam Department of Public Works;
