## AN ACT TO APPROPRIATE THE SUM OF FOUR HUNDRED THOUSAND DOLLARS (\$400,000) ESCHEATED TO THE GENERAL FUND, PURSUANT TO §21116 OF CHAPTER 21, DIVISION 2, TITLE 5, GUAM CODE ANNOTATED, TO THE DEPARTMENT OF REVENUE AND TAXATION FOR THE PURPOSE OF FUNDING THE AGENCY'S TRANSACTION PROCESSING SYSTEM.

#### **1 BE IT ENACTED BY THE PEOPLE OF GUAM:**

Section 1. Appropriation. Notwithstanding any other provision of law,
the sum of Four Hundred Thousand Dollars (\$400,000) escheated to the General
Fund at the end of Fiscal Year 2012 and available for appropriations in Fiscal Year

2013, pursuant to §21116 of Chapter 21, Division 2, Title 5, Guam Code
 Annotated, is hereby appropriated to the Department of Revenue and Taxation for
 the purpose of funding the agency's Transaction Processing System.

4 Section 2. Unused Appropriation. Funds *not* expended pursuant to the
5 provisions of this Act, within one year following the date of enactment, *shall no*6 *longer* be available to the Department of Revenue and Taxation, and *shall* become
7 available for future appropriations by *I Liheslaturan Guåhan*.

8 Section 3. Reporting Requirement. The Director of the Department of 9 Revenue and Taxation *shall* submit a report to *I Maga'lahen Guåhan* and *I* 10 *Liheslaturan Guåhan* on a monthly basis as to the obligation and expenditure of 11 the funds and the status of its implementation following the enactment of this Act, 12 detailing all transactions pertaining to funds appropriated herein.
