





**AN ACT TO AMEND § 1515(i)(2)(G) OF ARTICLE 5,  
CHAPTER 1 OF TITLE 5, GUAM CODE ANNOTATED,  
RELATIVE TO THE CONSTRUCTION, REPAIR AND  
IMPROVEMENTS OF THE GUAM FISHERMEN'S  
COOPERATIVE ASSOCIATION FACILITY.**

1           **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2           **Section 1.**   § 1515(i)(2)(G) of Article 5, Chapter 1 of Title 5, Guam Code

3           Annotated, is hereby *amended* to read:

1           “(G) for purposes of issuing a grant of *no more than* Five Million  
2 Dollars (\$5,000,000) to the Guam Fishermens Cooperative Association  
3 (GFCA) for the purposes of construction, repair and improvements of its  
4 facility as part of the Greg D. Perez Marina Economic Enhancement Master  
5 Plan.

6           *No* funds authorized in this Section *shall* be used to pay the Guam  
7 Economic Development Authority or its contracted consultants.

8           Notwithstanding the order of priority requirement in §1515(i)(2) and  
9 upon enactment, the sum of Two Million ~~Five Hundred Thousand~~ <sup>PEL</sup> Dollars  
10 <sup>900</sup> (\$2,700,000) of the proceeds are authorized, appropriated and *shall* be  
11 deposited and accounted for in a separate trustee sub-account for the  
12 payments of expenses associated with the construction, repair and  
13 improvements of the GFCA facility. Any services or contracts or expenses  
14 associated with the construction, repair and improvements of the GFCA  
15 facility under this grant *shall* require the approval of the GFCA.  
16 Disbursements for payments of expenses associated with the construction,  
17 repair and improvements of the GFCA facility *shall* be approved by the  
18 GFCA and countersigned by GEDA. The proceeds of the grant must be  
19 expended or encumbered by the GFCA for the purposes provided herein *no*  
20 *later than* July 31, 2015. *If* any funds authorized by this Section remain  
21 unexpended or unencumbered after July 31, 2015, the amount of the  
22 unencumbered or unexpended authorization *shall* be subject to legislative re-  
23 appropriation. Funds *not* authorized for expenditure by the GFCA in this  
24 Section are subject to legislative appropriation for tourism-related capital  
25 improvement projects. The GFCA *shall* report to *I Maga’lahi* (the Governor)  
26 and the Speaker of *I Liheslatura* (the Legislature) on a quarterly basis of all  
27 expenditures of this grant and other funds secured by the GFCA used for the

1 construction, repair and improvements of its facility until the grant is fully  
2 expended and the facility construction, repair and improvements are  
3 completed.”

4 **Section 2. Severability.** If any provision of this Law or its application to  
5 any person or circumstances is found to be invalid or contrary to law, such  
6 invalidity *shall not* affect other provisions or applications of this Law which can be  
7 given effect without the invalid provisions or application and to this end the  
8 provisions of this Act are severable.
