AN ACT TO AMEND § 1515(i)(2)(G) OF ARTICLE 5, CHAPTER 1 OF TITLE 5, GUAM CODE ANNOTATED, RELATIVE TO THE CONSTRUCTION, REPAIR AND IMPROVEMENTS OF THE GUAM FISHERMEN'S COOPERATIVE ASSOCIATION FACILITY.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. § 1515(i)(2)(G) of Article 5, Chapter 1 of Title 5, Guam Code

3 Annotated, is hereby *amended* to read:

"(G) for purposes of issuing a grant of *no more than* Five Million Dollars (\$5,000,000) to the Guam Fishermens Cooperative Association (GFCA) for the purposes of construction, repair and improvements of its facility as part of the Greg D. Perez Marina Economic Enhancement Master Plan.

No funds authorized in this Section *shall* be used to pay the Guam Economic Development Authority or its contracted consultants.

8 Notwithstanding the order of priority requirement in §1515(i)(2) and upon enactment, the sum of Two Million Five-Hundred-Thousand Dollars 9 $(\$2,\cancel{3}00,000)$ of the proceeds are authorized, appropriated and *shall* be 10 11 deposited and accounted for in a separate trustee sub-account for the 12 payments of expenses associated with the construction, repair and 13 improvements of the GFCA facility. Any services or contracts or expenses associated with the construction, repair and improvements of the GFCA 14 15 facility under this grant shall require the approval of the GFCA. 16 Disbursements for payments of expenses associated with the construction, 17 repair and improvements of the GFCA facility shall be approved by the GFCA and countersigned by GEDA. The proceeds of the grant must be 18 19 expended or encumbered by the GFCA for the purposes provided herein no 20 later than July 31, 2015. If any funds authorized by this Section remain 21 unexpended or unencumbered after July 31, 2015, the amount of the unencumbered or unexpended authorization shall be subject to legislative re-22 23 appropriation. Funds not authorized for expenditure by the GFCA in this 24 Section are subject to legislative appropriation for tourism-related capital 25 improvement projects. The GFCA *shall* report to *I Maga'lahi* (the Governor) 26 and the Speaker of *I Liheslatura* (the Legislature) on a quarterly basis of all 27 expenditures of this grant and other funds secured by the GFCA used for the



construction, repair and improvements of its facility until the grant is fully
expended and the facility construction, repair and improvements are
completed."

Section 2. Severability. If any provision of this Law or its application to any person or circumstances is found to be invalid or contrary to law, such invalidity *shall not* affect other provisions or applications of this Law which can be given effect without the invalid provisions or application and to this end the provisions of this Act are severable.
