Public Law 31-233 permits the Office of the Attorney General to transfer between object class allocation provided notification to the Governor and Speaker of the Guam Legislature is made at least fifteen (15) days prior to such modification.

The transfer is needed to pay for attorney fees related to a civil case, and to purchase additional miscellaneous supplies. This is to also ensure that there is sufficient funding in the object categories as we approach the closing of the end the of fiscal year.
