

To: The legislature of Guam



Dear Sir/Ma'am:

The Nail Salon Business owners and employees of Guam are writing to your respective office, to voice our concern regarding Ms. Kelly Nguyen, who is one of the candidates for the position of Board Member. Ms. Nguyen is also a Nail Salon owner, and it is understandable that competition among the nail salons in Guam, including hers, exists. However, this supposedly healthy competition was tainted due to a previous action taken by Ms. Nguyen - complaining against other nail salons about their unlicensed employees, knowing that she is also committing the same infraction. We. as a business community, are aware of this fact and as much as we are continually taking steps to correct and improve our own past business faux pas, we also strongly feel that Ms. Nguyen is not a suitable candidate for Board Membership. Because of her malicious complaint, she has caused a sense of unhealthy competition and distrust among nail salon business owners and employees.

We strongly believe that in order for an individual to be a Board Member, s/he must possess not only the legal qualifications, but more importantly, a sterling character and high sense of moral empathy. We need a Board Member who considers and functions for the well-being of the WHOLE Nail Salon Business Community, and not just his/her individual enrichment. We believe that Ms. Nguyen is not the most suitable candidate as a Board Member. For this reason, we are signing a petition against her candidacy and possible selection as one of the Board Members.
