Spalling and Roof leaks Repairs CFS Building

At the previous meeting, the Board approved \$25,000.00, from the Facilities Maintenance Fund to address the repair work on the aforementioned subject. However, according to the cost estimates provided by ProPacific Builders Corporations, the cost for roof leaks construction joint repairs, spallings and concrete crack repairs is estimated at \$22,100.00 per bay. The CFS building has a total of 10 bays that would amount to \$221,000.00. The roof hatch covers, two each, is a separate cost of \$12,000.00.

Based on this, Board approval is being requested to conduct repair work as indicated above for all bays in the total sum of \$233,000.00 utilizing the Facilities Maintenance Fund. Upon approval, management will commence the procurement bidding process through invitation for bids.

Repair of Mooring Bollard at F-6

On October 14, 2013, it was reported that a Bollard at F-6 was struck by a vessel or a Barge during its departure from Port wharfs. Visual site inspection conducted by Port Engineering discovered damages to the concrete base, and also found the entire bollard was tilted inward. The extent of damages is unable to be determined until such time the bollard is removed to inspect the conditions of the anchors, bolts, threads, including the displacement and structural concrete base. Currently the bollard is off limits and is not being used until repairs are made.

Based on this, Board approval is being requested in the amount of \$25,000.00 utilizing funds identified under the CIP Small Projects line item budget that will enable management to acquire price quotations to proceed with the repairs.
