Reference: Bill 236-32 (COR) Outsourcing 3rd Party Testing

Dear Senator San Nicolas:

Kudos! to the staff of Senator Aline Yamashita for their efforts in working towards helping our Department with what has been perceived as a shortfall in meeting the testing demands for prospective commercial motor vehicle operators, seeking an upgrade to their driver's licensing endorsements. We are in support of this Bill and in agreement with the intent and purpose. However, after thorough review, I believe additional work is needed to address a few issues that were discussed during meetings held with the Senator's Chief Analyst - Miss Tanya Mendiola, which are as follows:

- 1. Guam has not adopted the Commercial Driver's License (CDL) Program as defined in 49 CFR Parts 383; but yet the language used throughout the Bill references CDL's along with this federal provision that enforces CDL's for commercial motor vehicle operators.
- 2. Title 16 does not include a definition for CDL nor does it provide regulatory compliance to qualify for such licensing endorsements. At best, the current law provides for a Chauffeur's licensing endorsements referenced in Title 16 Chapter 3 Section 3101.
- 3. Currently, should this Bill pass into law our Department does not have the ability to immediately verify the license status of CDL's issued by other licensing jurisdictions.

Therefore, we recommend that additional effort be made to refine the language used to provide clarity as well as ensure compatible with respective provisions in Title 16. We look forward to working with your office to address these concerns. Sincerely, for command the Back (5)
