





AN ACT TO AMEND SECTION 3 OF PUBLIC LAW 30-83, RELATIVE TO THE COMPOSITION OF THE COORDINATING COMMITTEE OF THE 12TH FESTIVAL OF PACIFIC ARTS TO BE HELD ON GUAM IN 2016.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Section 3 of Public Law 30-83 is hereby *amended* to read:

"Section 3. Composition. The following *shall* constitute the membership of the 12th Festival of Pacific Arts Coordinating Committee (the "Committee"):

(a) the President of the Department of Chamorro Affairs;

2	and Humanities Agency;
3	(c) three (3) members, to be appointed by I Maga'lahi (the
4	Governor), representing the organizations active in the promotion o
5	the arts on Guam;
6	(d) a member of the Mayors Council of Guam, appointed by
7	the President of the Mayors Council;
8	(e) two (2) Members of <i>I Liheslatura</i> , to be appointed by the
9	Speaker, who may designate himself;
10	(f) the Chairperson of the Committee on Cultural Affairs of
11	Liheslaturan Guåhan or its successor;
12	(g) the Chairperson of the Board of Directors of the Guan
13	Visitors Bureau or his designee;
14	(h) the Speaker of the Guam Youth Congress or his
15	designee; and
16	(i) the Chairperson of the Committee on Tourism of
17	Liheslaturan Guåhan or its successor."
