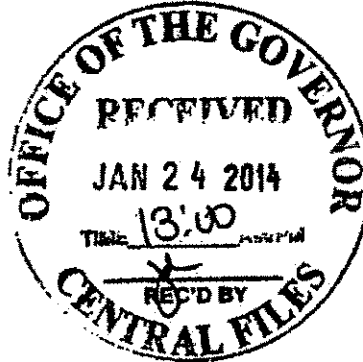

MEMORANDUM

TO: Governor of Guam

Reference: Westcare Pacific Islands, Inc.

SUBJECT: Second Certificate of Emergency for Sagan Mami Program

Guam Behavioral Health and Wellness Center (GBHWC) contracts with Westcare Pacific Islands, Inc., a non-profit organization providing management and operations of therapeutic activities for GBHWC's Sagan Mami Program, and the contract referenced above expired on September 30, 2013.


Sagan Mami is a "drop-in" program for the enrichment, employment support and peer mentorship of individuals with serious mental illness who are homeless or at imminent risk for homelessness, and approximately 200 individuals (consumers and non-consumers) will be affected if the service is discontinued for non-payment. GBHWC does not have adequate facilities and staff to offer this program.

Therefore, there exist a threat to the public health, welfare and safety of these individuals and thereby I declare a state of emergency at the Guam Behavioral Health & Wellness Center. Accordingly, I am authorizing emergency procurement as permitted by Section 5215, 5 GCA, Chapter 5 for the continuance of the service by Westcare Pacific Islands, Inc. for a monthly amount not to exceed Eleven Thousand Two Hundred Fifty and No/100 Dollars (\$11,250.00) from appropriate federal and/or local accounts.

I certify under penalty of perjury that the facts stated herein are true and that this declaration of emergency is not being used solely for the purpose of avoidance of the provisions of Title 5, Guam Code Annotated, Chapter 5, of the Guam Procurement Law.

This emergency declaration is effective upon the approval and shall expire ninety (90) days from date of signature by the Governor of Guam, or expire upon award by the Governor of Guam to the successful offeror of GBHWC Request for Proposal No. 06-2013
