Dear Governor Calvo and Speaker Won Pat:

Public Law 32-068 permits the Office of the Attorney General to transfer between object class allocation provided notification to the Governor and Speaker of the Guam Legislature is made at least fifteen (15) days prior to such modification.

It is also necessary that it be compatible with the current technology and programs.
