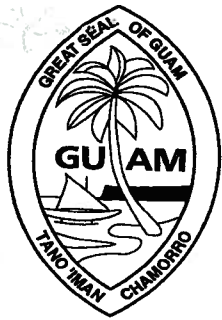

No new business.


