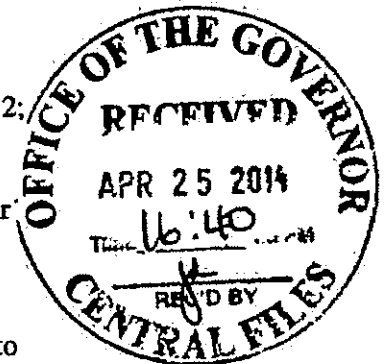

The Guam Behavioral Health and Wellness Center (formerly Department of Mental Health and Substance Abuse) contracts with a Medical Consultant to provide general medical services to the GBHWC-Healing Hearts Crisis Center (HHCC) which expired on September 30, 2012; namely Dr. Ellen Bez, MD, FACP who provides immediate assessment, diagnosis, treatment, evaluation, and ongoing consultation services for victims of sexual assault and/or abuse regardless of age, gender, ethnicity or disability.

Healing Hearts Medical Consultation services are currently 100% federally funded through the Edward M. Byrne Justice Assistance Grant subgranted to GBHWC-HHCC by the Bureau of Statistics and Plans. Dr. Bez has been providing Medical Consultation services to HHCC for over 15 years. In addition, GBHWC does not have adequate personnel to provide these services.

In FY 2004, an RFP went out with a 3 year renewal provision and was renewed each year. In FY 2007, another RFP went out with a 3 year renewal provision and was again renewed each year. For both processes, Dr. Bez was awarded the RFP with no one else responding to the RFPs. GBHWC is currently undergoing an RFP process to procure these services. The procurement efforts for Medical Consultation Services are continuing. DOA has issued the written determination for services, and public notice for the RFP is scheduled by the first week of May after review.

The ability of Healing Hearts to be able to provide critical services to victims of sexual assault and abuse is contingent upon having the Medical Consultant in place. HHCC is the only rape crisis center on this island and over 98% of rape kits are processed through the facility. The Medical Consultant services

include authorizing and prescribing medication and standing orders for laboratory testing given to victims, review of laboratory results and further recommendations to patients, as well as serving as the supervising physician for Sexual Assault Nurse Examiners conducting examinations. Victims of sexual assault and abuse are among the most vulnerable population on our island and the services provided are instrumental to client healing processes as well as successful prosecution of perpetrators and public health, welfare and safety of the island.

Thereby, I declare a state of emergency at the Guam Behavioral Health and Wellness Center. Accordingly, I am authorizing emergency procurement as permitted by Section 5215, 5 GCA, Chapter 5 for the continuance of services specified in the expired contract of the Medical Consultant mentioned above with payment from appropriate Federal funds.

I certify under penalty of perjury that the facts stated herein are true and that this statement of emergency is not being used solely for the purpose of avoidance of the provision of Title 5, Guam Code Annotated, Chapter 5, the Guam Procurement Law.

This emergency declaration is effective upon the date of signature by the Governor of Guam; and upon approval shall expire ninety (90) days from the date of effectuation, or expire upon award to the successful offerors for Healing Hearts Medical Consultation services.
