FLAGS LOWERED TO HALF-STAFF

As a mark of respect for the late former Mayor Pedro I. Borja of Chalan Pago-Ordot, and in accordance with U.S. Code Title 10, Section 175(m) and the Organic Act of Guam, as amended, I herein direct, by the authority vested in me as Governor of Guam, that the flags of the United States and Guam be flown at half-staff effective immediately until the day of interment, which shall be announced at a later date.

I also encourage all residents to display the flags at half-staff from their homes and businesses as we hold the family of the late former Mayor Pedro I. Borja in our hearts and lift them up in our prayers.
