WHEREAS, Pedro Iriarte Borja, born to Ana Benavente Iriarte and Francisco Borja Borja, on July 1, 1928, passed away on Friday, May 30, 2014 at the venerable age of eighty six (86) years; and

WHEREAS, during his younger days, late Honorable Pedro Iriarte Borja attended the Territorial College of Guam, wherein he was selected by his fellow students to serve as President of the College's Student Body; and

WHEREAS, the late Honorable Pedro Iriarte Borja served with great conviction, enthusiasm and honor, often communicating through personal visitations with his many colleagues; and

WHEREAS, the late Honorable Pedro Iriarte Borja, affectionately known as "Papa Pete" was an active Member of Tita's Day Care Center, serving as Director for more than Fourteen (14) years during his tenure; and

WHEREAS, the late Honorable Pedro Iriarte Borja was also an active member of the Guam Caregivers Association; now, therefore, be it

WHEREAS, prior to running for public office, the late Honorable Pedro Iriarte Borja devoted much of his time supporting programs for Senior Citizens activities; and

WHEREAS, in Ordot, the late Honorable Pedro Iriarte Borja was instrumental in developing recreational programs for the Ordot Community Advancement Association (OCAA), and for many years raised money for the San Juan Bautista parish; and

WHEREAS, the late Honorable Pedro Iriarte Borja, was a man who genuinely loved the people of Guam, demonstrating it daily in his unwavering service to his community for more than half a century, and receiving love from his community in return; now, therefore, be it

Gof piniti fina'pos-na, lao libre gui sa gaigegue'yan si Yu'us.


Pues basta tumanges, ya hasso gui gi annai man ha hamyu yan i magof siha na tiempo.

BE IT RESOLVED BY MUNICIPAL PLANNING COUNCIL OF BARRIGADA:

WHEREAS, longtime former Rota Mayor and family patriarch Prudencio Taisacan Manglona passed away on Tuesday, May 3, 2014 at the venerable age of 80; and

WHEREAS, the late Honorable Prudencio T. Manglona, affectionately known as *Tun Dencho* served the Commonwealth in numerous capacities and truly displayed what it means to be a productive and respected leader. Through his devotion to his faith and family values, *Tun Dencho* was a loving husband to the late Bernadita Atalig Manglona and an exemplary father to his children and grandchildren; and

WHEREAS, the people of the Commonwealth and Guam owe a debt of gratitude and a great deal of respect to them for their support and love they gave during his years in public service. The death of *Tun Dencho*, former mayor Manglona, is a deep loss for the people Rota and the Commonwealth but also the people of Guam; and

WHEREAS, the Late Honorable Prudencio Taisacan Manglona was instrumental in ensuring that tourists visit other islands in the Commonwealth while at the same time improving tourism throughout the Commonwealth; and

WHEREAS, the late Honorable Prudencio Taisacan Manglona was one of the Founding Fathers of the CNMI Constitution; and

WHEREAS, in celebrating his 80th Birthday on May 27, 2014, and in recognition of *Tun Dencho*’s exemplary innovative and progressive leadership in public service, community building, and economic development, CNMI senators presented him with a commemorative Resolution; now, therefore, be it
