



AN ACT TO AMEND § 5102(d) OF CHAPTER 5, TITLE 7, GUAM CODE ANNOTATED, RELATIVE TO THE POWER OF THE JUDICIAL COUNCIL TO ADOPT PAY SCHEDULES AND PLANS FOR NON-LAW ENFORCEMENT EMPLOYEES OF THE JUDICIARY OF GUAM; AND TO APPROPRIATE THE SUM OF FIVE HUNDRED TEN THOUSAND DOLLARS (\$510,000) FROM THE GENERAL FUND TO THE UNIFIED JUDICIARY FOR THE FY 2014 SALARY AND BENEFIT INCREASES OF ITS CLASSIFIED AND UNCLASSIFIED NON-LAW ENFORCEMENT EMPLOYEES.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 5102 (d) of Chapter 5, Title 7, Guam Code Annotated, is
3 hereby *amended* to read as follows:

4 “(d) Notwithstanding any other provision of law, to adopt a pay plan
5 and pay schedules for the classified and unclassified employees of the
6 Judicial Branch consistent with the government-wide plan pursuant to
7 Section 13 of Public Law 29-52 and Executive Order 2006-21, or the
8 transmittal of the “Government of Guam Competitive Wage Act of 2014” to
9 *I Liheslaturan Guåhan* on January 15, 2014, subject to appropriations as
10 provided by *Liheslaturan Guåhan*. Nothing in this Subsection (d) shall
11 repeal or negate the provisions contained in Public Law 32-136 applicable to
12 non-Judicial Branch employees; nor shall this Subsection (d) prohibit the
13 retroactive payment to January 15, 2014, of Judicial Branch employees;”

14 **Section 2.** Notwithstanding any other provision of law, appropriations
15 made to the Unified Judiciary in Chapter XI of Public Law 32-068 *shall* be used
16 for salary and benefit increases pursuant to Section 2(f) of Chapter XI of Public
17 Law 32-068.

18 **Section 3.** Appropriation to the Unified Judiciary. The sum of Five
19 Hundred Ten Thousand Dollars (\$510,000) is appropriated from the General Fund
20 to the Unified Judiciary for Fiscal Year 2014 salary and benefit increases for
21 classified and unclassified non-law enforcement employees consistent with
22 compensation policies adopted pursuant to 7 GCA § 5102(d), as amended.
