Hafa Adai Speaker Won Pat:

The Guam Election Commission respectfully requests your immediate assistance in addressing the absence of funding for Public Law \_\_\_\_\_ (Bill #334) an act to appropriate the sum of Two Hundred Six Thousand Five Hundred Fifty from the Supplemental Appropriations Revenue (SAR) Fund for the purchase of a ballot tabulation system, and the purchase of ballot stock and coding services...

I informed the Commission in a public meeting last night, that I received a call from Mr. Joey Calvo, Bureau of Budget and Management Research (BBMR) that there was no funding available in the SAR account. I also informed the Commission that the purchase of new tabulators with GEC current fiscal year funding will definitely cause a deficit and not afford the payment of precinct officials and other costs of the 2014 Primary Election.
