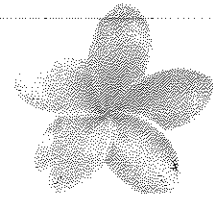

Your assistance in processing the zone change for Ms. Cleofe S.N. Susuico is greatly appreciated.

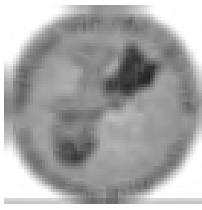

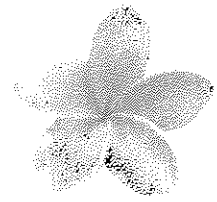

**RELATIVE TO SUPPORTING THE ZONE CHANGE APPLICATION FILED WITH THE DEPARTMENT OF LAND MANAGEMENT BY MS. CLEOFE S.N. SUSUICO FOR A ZONE CHANGE FROM "R-1" (SINGLE-FAMILY DWELLING) TO "R-2" (MULTI-FAMILY DWELLING) ON LOT NO 104-3-1 IN THE MUNICIPALITY OF MONGMONG-TOTO-MAITE, GUAM.**

1            **BE IT RESOLVED BY THE MONGMONG-TOTO-MAITE MUNICIPAL PLANNING**  
2            **COUNCIL:**

3            **Whereas**, Ms. Cleofe S.N. Susuico, are the owners of Lot No. 104-3-1, Municipality of  
4            Mongmong-Toto-Maite; and

5            **Whereas**, Ms. Cleofe S.N. Susuico have filed an application with the Department of  
6            Land Management requesting a Zone Change from "R-1" (Single-Family Dwelling) to "R-2"  
7            (Multi-Family Dwelling); and

8            **Whereas**, Ms. Cleofe S.N. Susuico intention for requesting the zone change in order to  
9            place two (2) existing residential dwellings into zoning compliance and for furture expansion to  
10           multi-family units for family and friends; and

11           **Whereas**, pursuant to Section 3 of Public Law 21-144 (Waiver of Formal Public  
12           Hearing), the Department of Land Management has elected to waive their requirements for a

1 formal public hearing and has deferred the hearing process to the Mongmong-Toto-Maite  
2 Municipal Planning Council; and


3       **Whereas**, the Chairman and members of the Mongmong-Toto-Maite Municipal  
4 Planning Council has discussed the proposed zone change request by Ms. Cleofe S.N. Susuico  
5 and are in the opinion that the zone change would not have any detrimental impact on the  
6 community, that the zone change would allow Ms. Cleofe S.N. Susuico to provide housing for  
7 their families and friends; and now, therefore be it

8       **Resolved**, that the Chairman and members of the Mongmong-Toto-Maite Municipal  
9 Planning Council hereby approve the zone change application filed with the Department of  
10 Land Management by Ms. Cleofe S.N. Susuico for a zone change from "R-1" (Single-Family  
11 Dwelling) to "R-2" (Multi-Family Dwelling); and be it further

12       **Resolved**, that the Chairman certify to and the Secretary attest to the adoption hereof  
13 and that copies of the same be thereafter transmitted to Ms. Cleofe S.N. Susuico; to the Director,  
14 Department of Land Management; to the Speaker of *I Mina Trenta Dos Na Liheslaturan Guåhan*;  
15 and to *I Maga Låhen Guåhan*, the Governor of Guam.




