

**AN ACT TO *ADD* A NEW SUBSECTION (c) TO § 4104
OF ARTICLE 1, CHAPTER 4, TITLE 4, GUAM CODE
ANNOTATED, RELATIVE TO THE PROOF OF
ELIGIBILITY FOR VETERANS PREFERENCE
CREDIT.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new Subsection (c) is hereby *added* to § 4104 of Article 1,
3 Chapter 4, Title 4, Guam Code Annotated, to read:

4 “(c) Proof of Eligibility for Veterans Preference Credit. Persons
5 claiming veterans status must submit their DD Form 214, Armed Forces of
6 the United States Report of Transfer or Discharge, DD Form 2 (Military

1 Identification Card), Certificate of Service, Department of Veterans Affairs
2 (DVA) Veterans Identification Card, or other official verification from the
3 Department of Defense (DOD). A person must have completed *at least* one
4 hundred eighty (180) cumulative days of service in the Armed Forces of the
5 United States, and must have received other than a dishonorable discharge
6 from such service to be eligible for veterans preference.”

7 **Section 2. Effective Date.** This Act *shall* become effective upon
8 enactment.

9 **Section 3. Severability.** *If* any of the provisions of this Act or the
10 application thereof to any person or circumstance is held invalid, such invalidity
11 shall *not* affect any other provision or application of this Act which can be given
12 effect without the invalid provision or application, and to this end the provisions of
13 this Act are severable.
