

#### BE IT ENACTED BY THE PEOPLE OF GUAM: 1

**Section 1.** Notwithstanding any other provision of law, the following lot 2 as described below is hereby rezoned from Agricultural Zone (A) to Commercial 3 Zone (C): 4 Lot No. P10.9A-3-16, in the municipality of *Dededo*, 5 containing 2,039 square meters, referenced to map filed

Section 2. Effective Date. The provision contained herein *shall* take effect upon enactment of this Act.

**Section 3. Severability.** *If* any provision of this Act or its application to any person or circumstance is held invalid, the invalidity *shall not* affect other provisions or applications of this Act which can be given effect without the invalid provision or application and to this and to this end the provisions of this Act is severable.
