##### **a. Management/Receiver's Report**

Receiver representative, Chace Anderson, described the tonnage report and stated that tons are down by 2%. Receiver Representative, David Manning, went over the revenue report. He reported that the Guam Water Authority did not make any payments in the month of August 2014 but they did make payment in September 2014. David Manning stated that billing seems to be stable at this time with the exception of Guam Water Authority. Mr. Manning went over the Operations Budget and the GBB Quarterly report files on June 25, 2014.

#### **V. Unfinished Business**

##### **a. Legal Counsel RFP-Status Update**

Interim Chair, Andrew Gayle, explained that the Evaluation committee along with Linda Ibanez and Chace Anderson had met with the candidates. The committee established a scoring system and ranked each candidate. A discussion ensued as to the particular qualifications of each of the candidates. Mr. Gayle and Interim Secretary, Elyze Iriarte, explained that all the candidates were eligible for the position and would represent the Board well and that the scoring was very close, however, they reported that Georgette Concepcion had ranked the highest based on the scoring system. They both suggested that the Board choose the highest ranking candidate.

Elyze Iriarte moved to approve the Evaluation Committee's selection and to authorize the Receiver to proceed in retaining Georgette Concepcion. The motion was seconded by Alexandra Taitano. Motion was carried.
