THE Port Authority of Guam will celebrate 39 years as a government of Guam agency this week with a proclamation signing as well as a parade of trucks and presentation of retirees who have worked at the port.

# Bill to expand funding for cancer prevention programs

LEGISLATION has been introduced to expand authorized programs supported by the Guam Cancer Trust Fund to include education and outreach programs.

Introduced by Sen. Dennis Rodriguez, Bill 406 seeks to allow funding for these types of programs in order to promote prevention, early detection and advanced treatment options that may not be considered direct services for cancer screening, treatment and support.

P.L. 30-80, which created the trust fund, currently restricts the fund's use to only nonprofit and charitable organizations providing cancer screenings, diagnosis and treatment.

The fund has been used to

provide financial assistance to these direct service organizations for other types of support services that may

be required to access treatment, including off-island transportation and temporary housing.

But according to Rodriguez's bill, it is unclear whether education and outreach programs and activities that seek to increase prevention and awareness of cancer issues can be funded through the trust fund. As a result,

"vital programs, trainings and events used to combat cancer may be forced to find alternative sources of funding," according to the bill. Rodriguez said cancer education and outreach is a major component of every public health campaign.

Moreover, "without a cancer education and outreach program, no matter how great a service is to the community, unless there is a proactive effort to publicize that service, it will likely be underutilized," Bill 406 states

Another intent of the measure is to amend the cap imposed on the use of grant funds for administrative purposes from

5 percent to 15 percent in "anticipation of the expanded programs organizations will take on in cancer education and outreach efforts."

Guam will need to enact screening techniques to catch these travelers who may potentially carry the deadly virus.

There are have been no reported cases of Ebola on Guam. The disease is not spread through the air or water, according to the U.S. Centers for Disease Control and Prevention. A person with Ebola can spread the virus after he or she has exhibited symptoms such as a fever. headache, diarrhea, vomiting, stomach pain, muscle pain or unexplained bleeding or bruising. It is only spread through direct contact with the blood and other body fluids of an infected person, needles, syringes, and animals that have been contaminated.

Koerner said there should be concern considering that diseases could be spread through travelers, but also said the publicity may be tied to politics.

"Unfortunately, some of it is tied to politics," he said.

"People are trying to take advantage of it. So there is a little bit more hype than usual but there is reason for concern. I mean, 70 percent mortality (rate), you don't want that — and (there's) no treatment."

So far in the U.S. there are three confirmed cases of Ebola with one patient dead. Koerner said as of now, Ebola patients are receiving experimental treatments. "Nobody knows if it works and some of the things that they've used, they're just not sure," he said. "I think anything that's demonstrated to be useful ought to be available on Guam."

Koerner is also a course director for the International Conference on Early Detection. The conference was held at the Hyatt Regency Guam and is a joint event organized by Cedars-Sinai Medical Center and the Guam Medical Association

The discussion about detection and prevention of an Ebola case on Guam happened almost accidentally at the conference, said Dr. Vince Akimoto, a local physi-

cian and conference attendee.
"Which is great because it's
a conference on early detection," Akimoto said.

Guam Homeland Security will be working with local doctors as well to develop a plan in case there is an Ebola diagnosis on Guam.

Koerner said he thinks more efforts should be made to try to contain the disease in West Africa and there might be possible travel bans put in place, but that has yet to be determined. "I think, probably, the way things are going with politics is there's going to be some travel bans. I think that's where it's going now but we'll see."

Maj. Josephine Blas, public affairs officer for the Guam National Guard, said no Guam Guard service members have been tasked to support the fight against Ebola.

According to a statement from the White House, President Barack Obama signed an executive order on Oct. 16 authorizing reserve members of the armed forces to provide support related to Ebola relief in West Africa.

## **New ER doctor at GMH to lead Guam Ebola preparations**

DR. GEORGINA Calderon is a new physician in the Guam Memorial Hospital's Emergency Department and will lead an Ebola response team, which hospital administrators put in place in the event the disease makes its way to Guam.

Calderon is an experienced physician specializing in emergency medicine who was working in Liberia at the start of the Ebola epidemic in West Africa earlier this year. She has been working at GMH for about a month.

"I've asked Dr. Calderon to help improve our Ebola preparedness here at GMH and she'skindly agreed,"said Joseph Verga, GMH administrator.

Verga said Calderon will be offering the insight she gained from her experience in Liberia. "The hospital is taking Ebola preparedness very seriously," Calderon said. "We're in the process of reassessing hospital preparedness as (Centers for Disease Control and Prevention) guidelines change."

A four-step plan has been proposed and Calderon said the plan will also include the input of some of her colleagues in California and Massachusetts.

Calderon said Guam is "thankfully remote" and the

risk of an Ebola case occurring here is low. "With that comes the thought that if it does happen, it's a very high-risk occurrence so we have to balance those things out," she said.

The four-step plan that will be developed in the coming weeks will take into account Guam's location, the doctor said.

#### Delighted

Verga said the hospital is "delighted" to have Calderon head the response team and that there is probably no one else

on the island with her medical background.

While she was in Liberia, Calderon said the conditions she worked under included the absence of running water and the facility she worked in ran on a generator. "It served a large area including some patients from neighboring counties. We were incredibly ill-prepared, nonetheless, I brought some privately donated personal protective equipment... we set up an isolation unit." she said. "It all really

comes down to preparation."

During her stay at a Liberia rural hospital, there were a couple of patients who they suspected had Ebola and were transferred to a larger hospital in the country that could treat the illness.

As Verga announced that Calderon would be leading the Ebola preparedness efforts, the hospital was wrapping up its International Infection Prevention Week complete with an Infection Control Fair, which

featured a display of facts about Ebola.

Calderon received her undergraduate degree in Massachusetts and moved on to get a degree at the Johns Hopkins Bloomberg School of Public Health followed by a medical degree from the University of California San Francisco. Calderon has worked in several countries and has been academically published about 30 times and speaks at least three languages

MARIA Pangelinan, Guam Election Commission executive director, reminded government employees yesterday that they are entitled, under the law, to two hours of leave on Nov. 4 to east their ballots.

WHEREAS,	the PDSC finds it necessary to upgrade Attorneys current workstations to either laptops or tablets in order to promote greater flexibility for Attorneys to utilize their laptops or tablets from office to court, which will enhance productivity; and		
WHEREAS,	a price quote of \$2,300 for each laptop or tablet with docking station has been obtained by the Public Defender Service Corporation MIS Administrator, which amounts to a total of \$18,500 for seven (7) laptops or tablets with docking stations; now therefore be it
