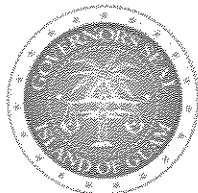

This letter is to respectfully notify you the Guam State Clearinghouse (GSC) has received a federal grant application from the Department of Agriculture's Division of Aquatic and Wildlife Resources (DOAg). **Details:** Funding from this grant will be used towards the maintenance of two species of Guam's endangered forest birds in captivity; the Ko'ko and the sihek (Kingfisher). Given certain difficulties with breeding on island, the birds were transported and a program for reproduction had initiated on Rota, CNMI. The captive breeding program on Rota has been successful since. Funds from this grant will be used towards personnel, travel between islands, supplies, equipment, utilities, and indirect costs of \$12,942.96.
