1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

- 2 Section 1. A new Item (18) is hereby *added* to § 4102(a) of Article 1 of
- 3 Chapter 4, Title 4, Guam Code Annotated, to read:
- 4 "(18) not more than one (1) Special Assistant each to the Attorney
- 5 General of Guam and the Public Auditor."
- 6 Section 2. Effective Date. This Act *shall* be effective upon enactment.
