III. NEW BUSINESS:

1. Motion Hearing:

Eleuterio J. Mesa vs. Department of Education; Case No. 11-AA13T

Present for Management were Attorney Rebecca Perez and Personnel Specialist IV Ray Lizama. Attorney Patrick Ceville represented Employee Eleuterio Mesa, who was also present.

The parties are to meet with Revenue and Taxation and Retirement to calculate taxes for Employee’s retirement and income tax payments and return a report of calculations.

1. Grievance Hearing (continuation):

Thaddeus Sanchez vs. Port Authority of Guam; Case No. 13-GRE-09

Present for Management were Attorney Michael Phillips and General Manager Joann Brown. Lay Representative Daniel Del Priore represented Employee Thaddeus Sanchez, who was also present.

By a vote of 6-0 the Commissioners voted to ratify the Grievance Review Boards findings and denied Employee's grievance.

2. Grievance Hearing (continuation):
Port Transportation, Stevedore, Terminal vs. Port Authority of Guam; Case No. 13-GRE-11

Present for Management were Attorney Michael Phillips and General Manager Joann Brown. Lay Representative Daniel Del Priore represented the Port Employees, who were also present.

By a vote of 6-0 the Commissioners adopted the Port's Grievance Review Board's findings to disregard the overtime provision. The Employees grievance was denied.
