**1.0 CALL TO ORDER**

The meeting was called to order by Chairman Michael Makio at 1:05 p.m., and roll call conducted.

**2.0 APPROVAL OF MINUTES (9/8/14 Meeting)**

Chairman Makio opened the floor for discussion on the minutes from the September 8, 2014, Board Meeting. The following corrections were noted:

Item 4.2.; Change to read, "Architecture Committee"

Item 4.2.; Second Project; Change to read, "Book on Guam's Architecture"

**Motion** Rebecca Duenas motioned to approve the minutes with corrections. The motion was seconded by Eric Forbes.

Joe Quinata responded to updates on the Book on Guam's Architecture, vehicle purchase, and the revenue report.

With no further discussion, the minutes were unanimously approved.

**3.0 EXECUTIVE SESSION**

Chairman Makio recessed the General Board meeting and entered into Executive Session.

At 1:55 p.m, Chairman Makio adjourned Executive Session and reconvened the General Board meeting.

Chairman Makio entertained a motion as a new agenda item in conclusion of the Executive Session, and opened the floor for discussion.

**Motion** Rebecca Duenas motioned, first to approve a pay adjustment increase of 3% for the Chief Program Officer and the Administrative Service Coordinator; and a bonus of one (1) paycheck; and second, a bonus of one (1) paycheck is to be given to each of the three (3) Special Project Coordinators. The motion was seconded by Eric Forbes and unanimously approved.

The performance evaluations of the Special Project Coordinators will be scheduled in January and coordinated by the Chief Program Officer and the Chair.

#### 4.0 OLD BUSINESS

##### 4.1. Board Orientation

##### 4.1.a. Date

Chairman Makio opened the floor for discussion on the venue and date to conduct the Board Orientation.

Joe Quinata suggested the Orientation be held on the morning of same day of the next scheduled Board meeting.

The consensus was to hold the orientation on January 26, 2015, at a location to be announced.

##### 4.1.b. Budget

To avoid delays in securing a venue and preparation, Joe Quinata recommended a not-to-exceed amount of \$1500.00, for the Board Orientation.

**Motion**

With no further discussion, Rebecca Duenas motioned to approve \$1500.00 for the Board Orientation. The motion was seconded by Dave Lotz and unanimously approved.

##### 4.2. Preparation of a Curriculum for Post Secondary Course(s) in Historic Preservation

##### 4.3. Curriculum for Secondary (high school) Course in Historic Preservation

Joe Quinata reported he will obtain assistance from the University of Guam and the Guam Community College with the process of introducing the pilot course, meeting with their Board, and conducting an evaluation of the pilot course.

Assistance will be needed for developing the content of the course.

Joe Quinata reported processing curriculum for secondary schools is more extensive. The Board will be advised upon further developments.

#### 5.0 NEW BUSINESS

##### 5.1. MARC Sponsorship

Joe Quinata reported a sponsorship request was received from the University of Guam for the Annual MARC event to assist in funding student research projects on histories of local community organizations.

**Motion**

With no further discussion, Dave Lotz motioned to approve \$5000.00, for the sponsorship of the 6<sup>th</sup> Annual MARC Dinner event. The motion was seconded by Rebecca Duenas and unanimously approved.

##### 5.2. GPT 25<sup>th</sup> Anniversary Activities

Joe Quinata presented a summary of proposed activities to collaborate with GPT partners.

The Board discussed the activities and schedule and suggested the following:

- To invite all contributing stakeholders to the Strategic Plan Celebration
- To partner youth with professionals in producing the vignettes
- To create a hybrid of the art competition & vignettes to be produced by youth
- To reduce the National History Day budget to \$30,000.00
- To have participants dress in the attire of the Spanish period as part of the 25<sup>th</sup>

#### Celebration at the Plaza

- To include Farmers and Fisherman's Co-op as part of the 25<sup>th</sup> Celebration event
- To prioritize the events
- To participate in the Marianas History Conference in Saipan

The Board discussed the demands on the staff in accomplishing the activities. Joe Quinata noted the activities involve the collaborative effort of staff and GPT partners, assuring the activities will not be labor intensive on the staff.

#### Motion

With no further discussion, Dave Lotz motioned to authorize Joe Quinata to proceed with the working list of 25<sup>th</sup> Anniversary items, to possibly be modified with a budget of \$152,000.00, and to report monthly back the Board.

The motion was seconded by Marilyn Salas and unanimously approved.

Chairman Makio called for a volunteer to Chair the Ad Hoc Committee for the Atantano Draft Usage Policy.

Dave Lotz volunteered to Chair the committee.

Staff will circulate an email asking for volunteers to serve on the committee.

#### 5.4. GPT By-Laws Review and Update

Chairman Makio called for a volunteer to Chair the Ad Hoc Committee for the review and update of the GPT By-Laws.

Dave Lotz volunteered to Chair the committee.

Staff will circulate an email asking for volunteers to serve on the committee.

### 6.0 COMMITTEE REPORTS

#### 6.1. BUDGET & FINANCE COMMITTEE

##### Refer to Report

##### 6.1.a. YTD Balance

Joe Quinata presented the Year End Administration and Operations report for FY14. A total of \$79,000 was unexpended for FY14.

The Administration and Operations expenditure summary as of November 30, 2014 was reviewed. The current fund available is \$6,856,516.61 with an unobligated fund of \$5,614,426.33, available for grants and projects.

The costs outlay for the Guam Legislature will commence in January 2015 once the construction bid is awarded.

Joe Quinata reported the FY14 audit is ongoing.

The Board discussed the grant and project balances status of the Plaza de España MOU, the Chagui'an, and Judiciary nomination grants.

#### 6.2. ARCHITECTURE COMMITTEE

##### Refer to Report

##### 6.2.a. FQ Sanchez Facility

Chairman Makio reported the Architecture Committee interviewed three firms and selected RIM Architects to provide Architectural and Engineering services for the F.Q. Sanchez facility. Staff was directed to obtain a fee proposal.

Joe Quinata reported RIM Architects responded with a fee proposal of \$208,054.49. RIM Architects provided a detailed breakdown of the fee as requested by the committee.

The Board discussed the submission.

**Motion** With no further discussion, Dave Lotz motioned to approve the expenditure of \$208,054.49, for the Architectural and Engineering services for the FQ Sanchez Facility. The motion was seconded by Eric Forbes and unanimously approved.

#### **6.2.b. Inarajan Homes**

Chairman Makio reported the committee reviewed the 100% submission drawings completed by Provido Tan Jones Architects. The next phase is to proceed with construction.

A more thorough review was conducted by the Chair and reported it was well executed and recommended to proceed with the bid for construction.

Joe Quinata clarified that archaeological monitoring and costs will be addressed in the construction phase.

**Motion** With no further discussion, Richard Olmo motioned to accept the 100% final completion drawings provided by Provido Tan Jones Architects, and to authorize staff to move into the construction solicitation phase. The motion was seconded by Rebecca Duenas and unanimously approved.

#### **6.2.c. Rosario House**

Joe Quinata reported the firm of Duenas and Camacho responded to the solicitation to prepare the Historic Structures Report (HSR) for the Rosario House, with a fee proposal of \$28,260.00.

The property has been cleared of debris.

With the assistance of the FSM Consulate's Office and the Guam Police Department, the individuals occupying the premise will be evacuated from the premise.

A request for quotation is being solicited for fencing.

Chairman Makio briefly reviewed and discussed the submission by Duenas & Camacho.

The schedule for completion of the HSR is ten (10) weeks which includes initial meetings, inspections, survey of the space, oral histories, archival documentation, invasive and non-invasive testing.

The Chair recommended approving the proposal and noted it included Glen Mason Architects, who are well known in historic preservation in the Pacific region.

**Motion** With no further discussion, Rebecca Duenas motioned to approve the proposal of \$28,260.00 by Duenas & Camacho to prepare the historic structures report for the Rosario House. The motion was seconded by Richard Olmo and unanimously approved.

### **6.3. GRANTS COMMITTEE**

#### **Refer to Report**

Joe Quinata reminded the Board of the existing moratorium on large grants.

**Motion** With no further discussion, Marilyn Salas motioned to lift the moratorium on the large grants. The motion was seconded by Dave Lotz and unanimously approved.

**6.3.a. A Year on the Island of Guam 1899-1900**

Grants Committee Chair Marilyn Salas reported the Committee reviewed the "A Year on the Island of Guam 1899-1900" grant submitted by Jillette Leon Guerrero.

The applicant provided a detailed budget and list of the funding partners for the project.

The committee recommended approval of the grant with the condition that 75 copies be provided to GPT for educational purposes.

**Motion**

With no further discussion, Dave Lotz motioned to approve the "Year of the Island of Guam" grant subject to the committee's recommended requirement of 75 copies to be provided to GPT for education purposes and approving \$10,000.00.

The motion was seconded by Rebecca Duenas and unanimously approved.

**I Am Chamorro Grant**

Eric Forbes reported an update.

The title of the documentary will be "Hayi Yu" (Who Am I?).

Filming will be conducted during the last week of February through the 1<sup>st</sup> week of March. Resources will be tapped during of filming and the Board was asked for support if asked to participate during the intense two week filming schedule.

**7.0 OPEN DISCUSSION**

-A Congressional award was presented to the Trust and to Joe Quinata during the APIA conference.

-A press release regarding GPT's opposition of the incinerator project was published in the Marianas Variety. A copy was provided.

-A photo chronology of the events held in 2014 was provided for the Boards review.


**8.0 ADJOURNMENT**

The meeting adjourned at 3:16 p.m.





# Proposed incinerator near heritage preserve

THE site for the proposed waste-to-energy facility is near Guam's first heritage preserve — one reason why the Guam Preservation Trust expressed opposition to the now-moot Bill 433.

The proposed legislation sought to approve the WTE project proposed by Guam Resource Recovery Partners and ratify the settlement agreement between the group, GovGuam and the Guam Economic Development Authority.

According to the trust, the development would result in changing the integrity of the area and adversely affect Guam's traditional cultural properties.

The trust was deeded 175 acres of land in the municipality of Piti and Santa Rita known as Atantano. According to the trust, it has designated the site as Guam's first heritage preserve, to be known as the Atantano Heritage Preserve, as the property contains multiple cultural, natural and historic resources that have the potential to increase the knowledge of Guam's history and heritage.

Moreover, the trust is designating the Atantano Heritage Preserve to promote the conservation and protection of the

environmental footprint for the community.

## Incomprehensible

"The notion of entertaining a proposal for a waste-to-energy facility next to what will be a heritage preserve seems completely incomprehensible," said Joe Quinata, Guam Preservation Trust's chief program officer. "We have called upon our island communities to help us stand with affirmation to conserve and preserve our cultural and natural heritage."

According to the trust, it is its vision and mission to preserve, promote and protect Guam's historic sites, culture and heritage through education, advocacy and community involvement.

Sen. Dennis Rodriguez, the chairman of the legislative committee on economic development, has decided not to report out Bill 433.

"I am going to take the prerogative as chairman of the committee to say that I will not move forward with this bill. This bill will not move forward in this term. It won't be reported out," he said.

Rodriguez made the announcement at the tail end of the public hearing for the measure on Friday. Members of the community who were in attendance applauded the decision.
