

#### **SUMMARY OF ACTIVITIES:**

#### Alee I Catherine's Home: Women's Shelter

October was a busy month for Alee I Catherine's Home. The shelter received a total of fortythree (43) calls. Two (2) calls were for client intake; Forty-one (41) calls were referred to the following organizations:

One (1) client referred to Guma San Jose, twenty-three (23) calls pertaining to clients personal affairs (outsource services GLSC, Oasis, etc), seven (7) calls were office related, three (3) called & Hung up, and seven (7) clients called inquiring about service, but did not call back to be picked up.

Eight clients from previous the month; and two (2) new clients new a total of ten (10) clients were sheltered for the month of October.

Client #1874-2- Client entered shelter on July 01, 2014 and was referred to Alee Shelter by "Guma San Jose Homeless Shelter." Client entered with 5 of her minor children and when at the shelter, was later joined by her other minor child, making her family size a total of 7 (6 children, 1 adult). While at the shelter, client was provided with transportation services to her appointments with GHURA, obtaining the proper clearance documents for GHURA (police clearance, mayor's certification, etc.), grocery shopping, obtaining a replacement SNAP card at the Department of Health and Social Services- Mangilao, transportation to various other related GHURA and Public Health appointments, and assisting her children with obtaining after school tutoring services from LAGU. While at the shelter, the Alee Shelter Program Manager coordinated with the Guma San Jose Homeless Shelter Program Manager in obtaining a temporary unit at the CSS-Guma San Jose Homeless Shelter Expansion Program, which allows for clients to stay at the units for 6 months. As soon as the client's unit was available for entering, client entered the CSS-Guma San Jose Homeless Shelter on October 21, 2014 at 6:30pm. \*Although client is under the CSS-Guma San Jose Homeless Shelter on October 21, 2014, case management and social work services will continue under the care of the Alee Shelter Social Worker. Client declined applying for a Protective Order.

Client #2165-1- Client entered shelter on August 13, 2014 and was referred to Alee Shelter by "Victim Advocates Reaching Out" Client was provided with transportation services to her medical appointments and shopping assistance. Client was also assisted with applying to Guma San Jose Homeless Shelter, which she was able to transition to after her 45 days at the shelter was up. Client exited shelter on October 01, 2014 and moved to the Guma San Jose Homeless Shelter program. Client declined applying for a Protective Order.

**Client #2219-** Client entered shelter on August 17, 2014 with 5 of her minor children. Client was assisted with applying at The Guam Housing and Urban Renewal Authority (GHURA) Public Housing Program and obtaining the proper documents for the application. Client was assisted with transportation services with dropping off and picking up her children to and from school, grocery shopping, and various other personal appointments client made. Client is currently waiting on a house from GHURA Public Housing Program. Client is number fifteen on the GHURA-Amp. #5 waiting list. Client declined applying for a Protective Order.

**Client #2083-1-** Client entered shelter on August 24, 2014 with 2 of her minor children. Client entered with no legal documents of herself or her kids, and was assisted with Victim Advocates Unit with going to her house to obtain the documents, however was unsuccessful, because client's perpetrator destroyed the documents. Client was assisted in applying for her birth certificate at the Federated States of Micronesia Consulate and received her birth certificate along with her eldest child's birth certificate, with the assistance of her auntie whose mailbox address the client was using to obtain the documents. Client obtained her birth certificate, along with her eldest child's birth certificate on October 27, 2014. Because client does not have any enough documents to be able to apply for any public services at the moment, Alee provides client and her children with food. Client was also assisted with transportation services to medical clinics when her youngest child needed medical attention. Client declined applying for a Protective Order.

**Client #2220-** Client entered shelter on August 29, 2014 with two of her minor children. Client was assisted with working on her GHURA Public Housing assistance, grocery shopping, updating her children's shot records at the Department of Public Health and Social Services, and seeking medical attention when the client and the client's children needed to seek medical attention. Client is currently waiting on housing from the GHURA Public Housing assistance. Client is number one on the GHURA- Amp. #3 Waiting Lists. Due to client breaking house rules of meeting with her boyfriend, who formerly threatened to come to the shelter because he knew of the location, at a location near the shelter (within 100ft.), client was evicted on October 27, 2014 at 2:30pm. Client is suspected of staying with her boyfriend or family members after her exit. Client wanted to apply for a Protective Order; however, during the process of interviewing with the lawyer from the Guam Legal Services, client stopped the process and did not pursue the Protective Order.

Client #2222- Client entered shelter on August on September 15, 2014 with her minor grandchild, whom she is the legal guardian of. Client was assisted with transportation services with the pick up and drop off of her grandson to her grandson's school, grocery appointments, and other personal appointments client made in regards to getting her child registered in school.

Client exited the shelter on October 3, 2014 and went to live back with her sister and brother-inlaw, whom were her former perpetrators. It was observed by staff that she was not fearful any more of her perpetrators when she was in constant contact with them during her stay the shelter. Client declined applying for a Protective Order.

**Client #2223-** Client entered shelter on September 18, 2014 with her minor grandchild, whom she is the legal guardian of. Client was assisted with transportation services in regards to dropping off and picking up her grandchild from school, grocery shopping, and connecting with her Salvation Army. Client was able to find an apartment with the assistance of Salvation Army paying for the security deposit. The client finding the apartment is the reason for the client's exit on October 01, 2014. Client declined applying for a Protective Order.

Client #2197-1- Client entered shelter on September 23, 2014 with two of her minor children. Client was assisted with providing transportation services in regards to dropping off and picking up her child to and from school and grocery shopping. Client was also assisted with applying for her birth certificate at the Federated States of Micronesia (FSM) Consulate. Client was in the process of waiting for the arrival of her birth certificate, and upon arrival was going apply for GHURA housing and other public benefits, however client exited the shelter before her birth certificate arrived. Client was assisted with obtaining a Protective Order against her perpetrator, which she received on October 08, 2014. Upon the arrival of her protective order, client exited the shelter on October 08, 2014 at 12:30pm and returned to her ex-boyfriend/common-law, who was her perpetrator.

**Client #2191-1-** Client entered shelter on October 09, 2014 with one of her minor children. Client later allowed for her child to stay with her mother-in-law for the duration of the client's stay at the shelter, with the understanding that her daughter was going to be safe with the client's mother-in-law. Client was assisted with transportation to and from her employment, grocery shopping, and applying for her social security card. Due to client constantly breaking house rules of returning back to the shelter after curfew, client was evicted on October 25, 2014 at 10:00pm. As of exit, client did not disclose where she is to stay upon her exit. Client declined applying for a Protective Order.

**Client #2224-** Client entered shelter on October 30, 2014, with 2 of her children (1 adult and 1 minor). The daughter, although is an adult is a special case, due to that she is a person with a disability and her mother is her primary caregiver. Client was assisted with food assistance. Client declined applying for a Protective Order at time of intake, but shared that she will have to confer with her child on his opinion of the matter before fully making her decision.

Special Cases:

**Family #1**: Family #1 entered the CSS-Guma San Jose Homeless Shelter Expansion Unit on October 10, 2014. The clients in Family #1 is a household of 5, to include 1 mother, and 1 adult child, 2 minor children, and 1 minor child whom the mother of the household has Power of Attorney over. Clients were assisted with applying and obtaining Supplemental Nutrition Assistance Program (SNAP), Medicaid, and Welfare assistance, enrolling 3 of the 4 children in high school (2) and middle school (1), assisting the remaining child with enrolling and taking the GCC-GED examination placement exam, transportation services to and from all related appointments mentioned above to include grocery shopping, and laundry services.

\*Case Management, Social Work and Transportation will be provided by the Alee Shelter staff and admin.

**Family #2**: Family #2 entered the CSS- Guma San Jose Homeless Shelter Expansion Unit on October 15, 2014. The clients in Family #1 is a household of 6 to include 1 mother, 1 father, 1 adult child, and 3 minor children. Clients were assisted with applying and obtaining Supplemental Nutrition Assistance Program (SNAP), Medicaid, and Welfare assistance, enrolling 1 of the 3 minor children in middle school and is currently working of getting the other 2 minor children enrolled in their respective grade levels and transportation services to and from all related appointments mentioned above to include grocery shopping.

\*Case Management, Social Work and Transportation will be provided by the Alee Shelter staff and admin.

#### Month of November

November was a busy month for Alee I Catherine's Home. The shelter received a total of fiftyseven (57) calls. Five (5) calls were for client intake; Fifty-two (52) calls were referred to the following organizations:

Four (4) clients referred to Guma San Jose, twenty-three (23) calls pertaining to clients personal affairs (outsource services GLSC, Oasis, etc), eight (8) calls were office related, four (4) called & Hung up, and thirteen (13) clients called inquiring about service, but did not call back to be picked up.

Three (3) clients from previous the month; and five (5) new clients for a total of eight (8) clients that were sheltered for the month of November.

Client #2224- and her 3 children, (Age 22 (person with disability), 17 & 13) entered the Catholic Social Service- Alee Family Violence Domestic Shelter on October 30, 2014. Client is a 47 year old, single Filipino woman of U.S. citizenship, and is a victim of intimate partner/ domestic violence- specifically that of physical and emotional abuse by her ex-boyfriend who she was living with prior to entering the shelter. Client mentioned that a police call was made last year regarding the abuse; however, the client dropped the charges because the perpetrator made threats. Client is a self-referring client who was able to meet Alee staff at the Alee Shelter pickup station and was brought to the shelter. Services provided to the client include transportation for her children to and from school and grocery shopping. During the arrival of one of the client's personal outings, it was noticed by an Alee staff that she had a hickey on her cleavage and that the person who dropped her off at the Alee Shelter pick up/ drop off station was a male. Upon returning to the shelter, the client was spoken to about the nature of her outing and the concern it posed for her and the shelter's safety. It was also brought about that she was not fearful anymore from her ex-boyfriend, that instead she would avoid him. It was then assessed that the client no longer needed Alee Shelter services. Client stated that she will move in with her mother and declined applying for a protective order.

Client #2219- and her seven (7) children, (Ages: 16, 14, 12, 11, 9, 7, 6) entered the Catholic Social Service- Alee Family Violence Domestic Shelter on August 17, 2014. Client is a 32 year old, married woman, and is a victim of intimate partner/ domestic violence - specifically that of physical and emotional abuse by her husband who she was living with prior to entering the shelter. Client declined applying for a protective order. Client was assisted with applying at The *Guam Housing and Urban Renewal Authority (GHURA) Public Housing Program* and was assisted with obtaining the proper documents for the application. Client was also assisted with transportation services with dropping off and picking up her children from school, grocery shopping, and various other personal appointments client made. During the client's stay at the shelter, the client was caught consuming alcohol with another client, which was in violation of the shelter rules, and was evicted the next day to family members.

Client #2083-1- and her two (2) children, (Ages 6 and 1) entered the Catholic Social Service-Alee Family Violence Domestic Shelter on August 24, 2014 at 4:25am. Client is a 32 year old, single Chuukese woman of FSM (Federated States of Micronesia) citizenship, and is a victim of intimate partner/ domestic violence and family violence- specifically that of physical abuse by her ex-boyfriend who she was living with prior to entering the shelter. A police incident report was made on August 24, 2014 at the Hagatna Precinct however no arrests were made. Client was referred to Alee Shelter by *Guam Police Department's- Victims' Assistance Unit*. Client entered with no legal documents for herself or her children and was assisted by *Guam Police*  Department's- Victims' Assistance Unit in transporting the client to her house to obtain the documents, however was unsuccessful, because client's perpetrator destroyed the documents. While at the shelter, the client was assisted in applying for her birth certificate at the *Federated States of Micronesia Consulate* and received her birth certificate along with her eldest child's birth certificate, with the assistance of her aunt whose mailbox address the client used to obtain the documents. Client obtained her birth certificate, along with her eldest child's birth certificate on October 27, 2014. Because client did not have enough documents to apply for any public services at the time of her stay, Alee provided the client and her children with food. Client was also assisted with transportation services to medical clinics when her youngest child needed medical attention. Client declined applying for a Protective Order. During the client's stay at the shelter, the client was caught consuming alcohol with another client, which was in violation of the shelter rules, and was evicted the next day to her family member.

#### Special Note:

4 *Child Protective Services* Referrals were made at the shelter during the client's stay in regards to neglect.

**Client #2225** entered the Catholic Social Service- Alee Family Violence Domestic Shelter on November 13, 2014 at 11:00pm. Client is a 37 year old, separated Chamorro woman of U.S. citizenship, and is a victim of intimate partner/ domestic violence- specifically that of physical and emotional abuse by her ex-girlfriend whom she was living with prior to entering the shelter. A police incident was made on November 07, 2014. No arrests were made with the police report. Client was referred to the Alee Shelter by the *National Census of Domestic Violence*. Client was able to meet Alee staff at the Alee Shelter pick-up/ drop-off station and was brought to the shelter. Services provided to the client include transportation to and from client's employment. Upon exit, client did not disclose where she was exiting to. Client declined applying for a protective order.

Client #2226 and her two (2) children (Ages 1 and 11months), entered the Catholic Social Service- Alee Family Violence Domestic Shelter on November 19, 2014. Client is a 25 year old, single Ponapean woman of U.S. citizenship, and is a victim of intimate partner/ domestic violence- specifically that of physical and emotional abuse by her ex-boyfriend whom she was living with prior to entering the shelter. Client was 6 months pregnant upon entering the shelter. A police incident report was made at the Hagatna Precinct on February 2014, and an arrest was made. Services provided to the client include transportation services to do grocery shopping and transportation to the Guam Medical Hospital when the client's daughter needed medical attention. The day the client took her daughter to the hospital, client stated that she was going to exit the shelter and stay with her mother in order to help care for her sick daughter. Client said that she was going to call back the night her daughter was taken to the hospital; however client did not. Client contacted the shelter the following day and came in to clean out her room in preparation for her exit. Upon exit, client stated that she will move in with her mother. Client declined applying for a protective order.

Client #1509-1, and her three (3) children, (Ages 2, 1 and 3months) entered the Catholic Social Service- Alee Family Violence Domestic Shelter on November 20, 2014. Client is a 35 year old, single Chamorro woman of U.S. citizenship, and is a victim of intimate partner/ domestic violence- specifically that of emotional abuse by her ex-boyfriend who she was living with prior to entering the shelter. A police incident was made on November 20, 2014. Client was referred to Alee Shelter by the *Guam Police Department- Victims' Assistance Unit*, who also assisted client meet with Alee staff at the Alee Shelter pick-up/ drop-off station and was brought to the shelter.

Services provided to the client include transportation to meet with the client's friend at the Alee Shelter pick-up/ drop-off station and a personal appointment/ outing. During the client's personal outing on November 22, 2014 client did not return back to the shelter. Upon exit, client did not disclose the location of her exit. Client declined applying for a protective order.

Client #2228 and her child (Age 8) entered the Catholic Social Service- Alee Family Violence Domestic Shelter on November 24, 2014 at 10:53pm. Client is a 34 gear old, divorced Kosraen woman of U.S. citizenship, and is a victim of intimate partner/ domestic violence- specifically that of physical and emotional abuse by her ex-boyfriend whom she was living with prior to entering the shelter. A police incident was not made and no arrests were made. Client was a selfreferring client who was able to meet Alee staff and the Alee Shelter pick-up station and was brought to the shelter. Upon further assessment, it was found that the client's case was not that of domestic violence, but rather a marital/ homeless situation. Upon exit, client stated that she will move back in with her ex-partner. Client declined applying for a protective order.

## <u>Clients from the Catholic Social Services- Guam San Jose Homeless Shelter- Housing</u> <u>Expansion Unit</u>

#### Family #1:

Family #1 entered the CSS-Guma San Jose Homeless Shelter Expansion Unit on October 10, 2014. Family #1 is a household of five (5), to include mother, and one (1) adult child, two (2)

Clients were assisted with applying and obtaining Supplemental Nutrition Assistance Program (SNAP), Medicaid, and Welfare assistance, enrolling three (3) of the four (4) children; two (2) in high school and one (1) in middle school, and assisting the remaining child with enrolling and taking the GCC-GED examination placement exam, transportation services to and from all related appointments mentioned above to include grocery shopping, and laundry services.

\*Case Management, Social Work and Transportation will be provided by the Alee Shelter staff and admin.

## Update:

Client (mother) is currently waiting on monetary assistance from the AG's office in order to obtain police, court, and traffic clearances in pursuit of employment. Clients were assisted with searching for hiring businesses. Clients were assisted with transportation to the grocery store, bank, Public Health appointments (specifically child school physical and lab appointments), and appointments with the AG, by Alee staff. Clients were assisted with I'Famagunta's SW, to set up a home orientation of I'Famagunta services. Client (mother) was also assisted with helping client (mother) and client's child (youngest son) in report bullying incidents regarding the child (youngest son) to the child's vice principal.

- Client (daughter) will begin GED classes in February 2015.

- Clients (mother and father) plan on seeking employment and saving up money in order to move out of the Expansion Unit.

## Family #2:

Family #2 entered the CSS- Guma San Jose Homeless Shelter Expansion Unit on October 15, 2014. The clients in Family #2 is a household of six (6) to include mother, father, one (1) adult child, and three (3) minor children. Clients were assisted in applying; obtaining Supplemental Nutrition Assistance Program (SNAP), Medicaid, and Welfare assistance, enrolling one (1) of the three (3) minor children in middle school and is currently working of getting the other two (2) minor children enrolled in their respective grade levels and transportation services to and from all related appointments mentioned above to include grocery snopping.

\*Case Management, Social Work and Transportation will be provided by the Alee Shelter staff and admin.

Update:

Clients are currently waiting on monetary assistance from the AG's office in order to obtain police, court, and traffic clearances in pursuit of employment. Clients were assisted with searching for hiring businesses. Clients were assisted with transportation to the grocery store, bank, Public Health appointments (specifically child school physical and lab appointments), and appointments with the AG, by Alee staff. Clients were assisted with l'Famagunta's SW, to set up a home orientation of l'Famagunta services. Client (mother) was also assisted with helping client (mother) and client's child (youngest son) in report bullying incidents regarding the child (youngest son) to the child's vice principal.

Clients (mother and two daughters) plan to enroll in the I' Famagunta GED Program
Clients (mother, father, and second eldest son) plan on seeking employment and saving up money in order to move out of the Expansion Unit

#### For the month of December

December was a busy month for Alee I Catherine's Home. The shelter received a total of twentyfour (24) calls. Six (6) calls were for client intake; Eighteen (18) calls were referred to the following organizations:

Three (3) client referred to Guma San Jose, four (4) calls pertaining to clients personal affairs (outsource services GLSC, Oasis, etc), four (4) calls were office related, two (2) called & Hung up, and five (5) clients called inquiring about service, but did not call back to be picked up.

Three (3) clients from previous the month; and five (5) new clients new a total of eight (8) clients were sheltered for the month of December.

(Client #2227) Client entered the shelter on November 20, 2014 with two (2) of her minor children, ages seven (7) and five (5). Client is a 23 year old single Chamorro woman with U.S. citizenship. Client was assisted with transportation with picking up and dropping her children to and from school, dropping off her kids to the their babysitter, applying for Public Assistance benefits to include; *Supplemental Nutrition Assistance Program* and Welfare benefits, following up with the client's *Guam Housing Urban Renewal Authority* status, grocery shopping transportation, and apartment seeking. Client declined to apply for a protective order.

(Client #2229) Client entered the shelter on December 01, 2014 with two (2) of her minor children, ages three (3) and one (1). Client is a 42 year old single Pohnpeian woman of FSM citizenship, who is a permanent resident alien. Client provided most of her own transportation because she had her own vehicle. Client was able to obtain a job within her first two (2) weeks at the shelter. Client also applied for and received a protective order.

(Client #2231) Client entered the shelter on December 14, 2014 with her minor child who is four (4) years old. Client is a 30 year old single Chuukese woman of FSM citizenship, who is a permanent resident alien. Client was assisted with applying for public benefits (i.e. welfare, Supplemental Assistance Nutritional Program) and obtaining the required documents for the application. The client was also assisted with applying for a protective order and was able to obtain one.

(Client #2105-1) Client entered the shelter on December 29, 2014. Client is a 34 year old single Chuukese woman of U.S. citizenship. Client was assisted with applying for a protective order; however the client was not able to receive the order due to "insufficient evidence." She is currently an on-call employee and is working on more permanent employment.

Client #2230 and her two children, ages thirteen (13) and eight (8), entered the Alee Family Violence Domestic Shelter on December 02, 2014 Client is a 36 year old, single Filipino woman of U.S. citizenship, and is a victim of intimate partner/ domestic violence- specifically that of physical and emotional abuse by her common-law partner who she was living with prior to entering the shelter. A police incident report was made at the client's residence. Client was assisted with applying at the Guam Housing and Urban Renewal Authority (GHURA) Public Housing Program (GHURA) and was assisted with obtaining the proper documents for the application. Client was also assisted with applying and obtaining employment during her stay at the shelter. Client provided most of her own transportation but was accompanied by the Alee staff for appointments where support was needed by the Social Worker. In addition to transportation services, client was also assisted with filing a harassment report against her perpetrator's family; however, the report did not materialize, according to the officer assisting at the time due to the fact that she did not have substantial proof of the harassment, such as text messages from the harasser. The perpetrator's family harassed the client in the form of constant calling and hanging up when the client answered the phone. Client exited on December 25, 2014 at 9:40pm. Client provided her own transportation during exit. Upon exit, client informed the social worker that she will move in with her sister while waiting for her apartment to be available for move in January. Client declined applying for a protective order

Client #2233 entered the Catholic Social Service- Alee Family Violence Domestic Shelter on December 21, 2014. Client is 28 year old, divorced Japanese woman of Japanese citizenship (\*Client was visiting Guam on a Visa), and is a victim of intimate partner/ domestic violence- specifically that of physical and emotional abuse by her boyfriend, who is a resident of Guam. A police incident report was made at the Tamuning Precinct on December 21, 2014, however no arrests were made. Client was referred to the Alee Shelter by the *Guam Police Department- Victims' Assistance Unit*, who assisted in bringing the client to the shelter upon entry. Services provided to the client include transportation to the *Guam Memorial Hospital* to seek medical attention. While client was seeking medical attention at the Guam Memorial Hospital on the day of her intake, she called the Alee Shelter around 5:10pm to ask if she could stay with her friend instead, and was informed by the staff that she could do so if she wanted. Therefore, client informally exited the Alee Shelter at that time.

Client # 2232 and her three (3) children, ages four (4), three (3), and one (1), entered the Catholic Social Service- Alee Family Violence Domestic Shelter on December 16, 2014. Client is a single 22 year old Chuukese woman of FSM citizenship (\*permanent resident alien), and is a victim of intimate partner/ domestic violence- specifically that of physical and emotional abuse by her boyfriend whom she was living with prior to entering the shelter. A police incident report was completed however no arrests were made. Client is a self-referring client who was able to meet Alee staff at the Alee Shelter pick-up/drop-off station and was brought to the shelter. Services provided to the client include transportation services during the client's entry and exit. \*During client's stay at the Alee Shelter, it was assessed that there was a misinterpretation of the services that Alee provides, in that the client thought that Alee assisted with housing and would assist her and boyfriend with living arrangements to include him staying at the shelter. Upon client being fully informed of the true scope of services that Alee provides, client exited and moved back to family and boyfriend.

## <u>Clients from the Catholic Social Services- Guam San Jose Homeless Shelter- Housing</u> <u>Expansion Unit</u>

#### Family #1 Update:

Mother is working on job training opportunities with the Health Professional Licensing Office (HPLO) under the Guam Department of Public Health and Social Services and will begin her orientation and job training sessions in January of 2015. Mother is working on applying for housing with the Guam Housing Urban Renewal Authority (GHURA) with the assistance of the I'Famagunta team and the Alee Shelter Social Worker.

Daughter is currently receiving counseling services under the I'Famagunta Program once a week for ten (10) weeks. Daughter is expected to start GED classes at GCC in January of 2015.

Transportation and referral services regarding the related appointments mentioned above were provided by the Alee Shelter staff.

## Family #2 Update:

Mother and father were seeking employment opportunities and will continue to do so.

Daughters plan to attend the l'Famagunta GED Program when the program is up and running. The Alee Shelter Social Worker will work with the mother to withdraw the daughter from JFK and in obtaining the related transcripts needed to enroll in the GED program.

Transportation services were provided by the clients who were assisted by their family members and themselves. Father owns a scooter and drives it whenever possible.

#### Alee II Shelter for Abused or Neglected Children

The month of October we served a total of three (3) children. We currently have three (3) Chamorro girls; all the children are placed here at the shelter through Child Protective Services. The shelter continues to provide Personal Care, Teaching Life Skills, Transportation and Recreational Outings for all the children in the shelter.

A Chamorro family of three (3) girls arrived late this month. The girls are ages 10, 7 and 5. The two (2) younger girls did not have any problems adjusting to the shelter. The oldest one on the other hand, took it really heard. Pamela Brewster (CPS caseworker) informed shelter staff that the previous foster home did not have any behavioral issues concerning the girls. The girls attend school at Finagayan Elementary School.

#### Accomplishments:

After closing on September 19, 2014, the Shelter is now in compliance with the American with Disabilities Act and our License was approved on October 17, 2014. The shelter re-opened the same day.

The landlord had the back patio redone and all damages to balusters have been repaired.

#### **Maintenance Issues**

- Driveway, sidewalks, patio and garage need water blasting.
- Trees in the back yard need to be trimmed
- Washing machine needs to be checked problems with water level
- Dining table and chairs need to be replaced wobbly
- Dressers in the children's rooms need replacing
- Shower drains need to be checked slow drain

#### For the month of November

The month of November we served a total of six (6) children. We currently have three (3) Chamorro girls, and three (3) boys, all the children are placed here through Child Protective Services. The shelter continues to provide Personal Care, Teaching Life Skills, Transportation and Recreational Outings for all the children in the shelter.

A Chamorro family of three (3) girls are still residing here at the shelter. The girls are ages ten (10), seven (7) and five (5). The girls are adjusting to the shelter very well. The 10 year old had an awesome month, she was awarded student of the month and came in  $3^{rd}$  place in her school Spelling Bee competition. The three (3) girls had a visit with stepfather, father and grandmother. The visit was supervised by Child Protective Services. The oldest had one (1) visit with her biological father at Child Protective Services office with the assigned caseworker supervising the visit. The three (3) girls also had three (3) sessions at Project Karinu. The girls had all their dental work done this month.

A Chamorro family of three (3) boys arrived late in the month. The boys are ages four (4), three (3) and two (2). When the boys arrived at the shelter they were not shy and seemed to be comfortable with the staff and the other children. The boys are learning the rules and routine of the shelter. So far the boys have not had any contact with any family members.

#### Accomplishments:

All the staff have meet the required trainings hours, education, or experience that is required by CEDDERS (Center for Excellence in Developmental Disabilities Education, Research & Services) for the GPPD (Guam's Plan for Professional Development Path A).

#### For the month of December

This month we served a total of twelve (12) children. All the children served this month are all Chamorro. All children here at the shelter are placed here through Child Protective Services (CPS). The shelter continues to provide Personal Care, Teaching Life Skills, Transportation and Recreational Outings for all the children in the shelter.

We currently have a family of seven (7) children, two (2) boys and five (5) girls. They range between the ages of one (1) and thirteen (13). Three (3) of the children have been in the shelter for two (2) months while the other four (4) came in the beginning of this month. The children had one (1) visit this month with step-father, father, grandmother, aunties and uncles. The oldest boy had one (1) session with Project Karinu, the oldest girl had two (2) sessions while the third child had one (1) session. Behaviors and concerns with the children are being addressed at WRAP meetings which are attended by Program Manager and Shelter Coordinator. Two (2) WRAP meetings were held in the month of December. The oldest boy voiced his interest in playing soccer, the Program Manager was able to identify a sponsor to cover all expenses for him to join the league. The season begins mid-January 2015. All in all, all the children are doing well and have adjusted to the shelter's rules and routines.

We have a family of three (3) boys, ages five (5), three (3) and a one (1) year old. When the boys first arrived in November, hitting and vulgarity were common. The staff has been working

diligently with them and the hitting has stopped and the vulgar language has slowed considerably. The boys have not had any contact with any family members since they were placed in the shelter. The boys are adjusting and are beginning to abide by the rules of the shelter.

We have a family of two (2) girls. The girls are sixteen (16) and fourteen (14) years old. The sixteen (16) year old is 7 ½ months pregnant. The girls attend John F. Kennedy High School. The Program Manager accompanied the fourteen (14) year old to an appointment with Healing Hearts Crisis Center. The sixteen (16) year old has an appointment scheduled for January 5, 2015. The girls have not had any contact with family since being placed at the shelter. The sixteen (16) year old receives assistance from the Women Infant & Children (WIC) program. She is seeing Dr. Griley of the Polyclinic for all her prenatal care. The girls are doing well and have adjusted to all the rules and routines here of the shelter.

#### **Transitional Housing**

Three no-cost, safe, and secure two-bedroom apartment units are rented under the Alee Shelter's Transitional Housing Program. The program currently serves a total of 1 client. The client and her son, who lives with her, were referred through the Alee Family Violence Domestic Shelter.

The client entered the program on July 9, 2013 and has one minor child who lives with her. The client is the primary caregiver for her child. Client's son visits his father, who is the ex-partner of client, but the client is the primary caregiver. Client is currently waiting on a settlement agreement in regards to legal action taken upon negligence by GMHA and DPHSS. Due to client's poor health condition, client is unable to find steady employment. According to client, client's foot becomes swollen as a result from a urethral stent left in her body for more than a year, which she still has. This urethral stent affects her kidney function ability, which results in frequent swelling of her feet, which was seen during the home visit.

Upon visitation of the client, the social worker gave the client the GHURA- Public Housing Assistance Application to fill out, which the client mentioned last month she was interested in applying for, and assisted the client with any questions she had with the application. Furthermore the client was provided with the Verification of Residency for the application.

As for the client's *Financial Plans* and *Employment Stability* goal of cooking and selling baked goods, which was established August 0f 2014. The client has had success during last month of selling bakes goods, to include tamales gizu and empanada, at a family medical fundraiser event and from family members and friends who order the client's good for family gatherings. Client had two orders for the month of October for tamales gizua and lumpia and plans on expanding her clientele to businesses that will allow her to come in from time to time to sell her cooked

goods during their lunch hour. Client shared that she has a health certificate, but would like to work on getting her business license.

Client's *Housing Stability Goals* include seeking housing and moving out of the Alee Shelter Transitional Housing Program (TH) after the settlement with her lawyer and the GMHA and DPHSS is settled.

\*\*\* Due to Alee Shelter not hearing back from grant funders to ensure if the Alee Shelter Transitional Housing Program will continue onto the next grant period, the social worker will work with the client in transitioning out of the housing program by the end of next month.

The social worker and program manager will continue to look for training opportunities that will enhance the welfare of the current and future clients who seek our services.

#### For the Month of November

Client transitioned out of the Alee Shelter Transitional Housing Program on November 31, 2014.

The Transitional Housing Program grant expired on September 30, 2014, however, Catholic Social Service continued to provide TH assistance to client until client transitioned. TH program funding was not renewed


