Dear Governor Calvo and Speaker Won Pat:

Public Law 32-181, Chapter VII, Section 3 permits the Office of the Attorney General to transfer between object class allocations provided notification to the Governor and Speaker of the Guam Legislature is made at least fifteen (15) days prior to such modification.

The transfer is necessary to cover additional costs for professional services in anticipation of hiring experts to assist in the Department of Corrections Settlement Agreement, as well as to fund drug testing costs of prospective applicants as we work to fill vacancies in our agency.
