Dear Speaker Won Pat:

In complying with Section 13 of Chapter 7, Public Law 32-181, we request the approval of *I Liheslaturan Guåhan* for the release and expenditure of lapsed funds from three continuing accounts of the Division of Environmental Health (DEH) of this Department, specifically the FY 2009 Environmental Health Fund, FY 2010 Environmental Health Fund, and the Controlled Substances Diversion Fund.

The funds from the two Environmental Health Fund accounts will be used for DEH operation, to include procurement of items and services for the Guam Environmental Public Health Laboratory (aka, the "mosquito lab") that is slated for completion this fiscal year, and field instruments used to conduct environmental health inspections and investigations. The lapse funds of the Controlled Substances Diversion Fund will be expended to support the activities of the division's Controlled Substances Program and the Prescription Drug Monitoring Program to combat the diversion of pharmaceutical controlled substances.

The following are the amount sought from each lapsed funds and anticipated use:
